I	am sharing	this letter to notify	you of a breac	h of our Private	Care Therapies,	LLC's ("PCT")	payroll
account v	which may	have compromised	our current an	d former employ	ees' sensitive pe	rsonal informat	ion,

Upon detection, the payroll system was immediately disabled and PCT transitioned to ADP, a commercial payroll provider. Working with a cybersecurity consultant, a number of other measures were instituted to augment the security of our internal information systems.

specifically employee social security numbers. The breach was discovered on November 14, 2024.

Under the Massachusetts Data Breach Notification Law (201 CMR 17.00), you are entitled to obtain a copy of the police report in this matter. On November 17, 2024, PCT notified the BPD Jamaica Plain police agency of the breach.

You may freeze your credit in order to prevent creditors from getting your credit information, which prevents identity thieves from opening accounts using your credentials. Information concerning how to free your credit is attached to this notification.

Additionally, pursuant to the Massachusetts data breach law, PCT has contracted with Experian to provide you with complimentary credit monitoring services for 24 months. In order to activate those services, see below for details.

To help protect your identity, we are offering complimentary access to Experian IdentityWorksSM for 2 years.

If you believe there was fraudulent use of your information as a result of this incident and would like to discuss how you may be able to resolve those issues, please reach out to an Experian agent. If, after discussing your situation with an agent, it is determined that identity restoration support is needed then an Experian Identity Restoration agent is available to work with you to investigate and resolve each incident of fraud that occurred from the date of the incident (including, as appropriate, helping you with contacting credit grantors to dispute charges and close accounts; assisting you in placing a freeze on your credit file with the three major credit bureaus; and assisting you with contacting government agencies to help restore your identity to its proper condition).
