Notice of Data Breach

Dear Sample:

We are writing to inform you that Mercury Aircraft, Inc. ("Mercury") recently experienced a cybersecurity incident that could have potentially involved your personal information.

<u>WHAT WE ARE DOING</u>: In order to protect against similar incidents in the future, we are taking several precautionary measures, such as changing passwords and modifying internal e-mail settings and controls. We are also engaging in increased user training to further protect our environment.
