Jewish Child Care Association of New York ("JCCA") is writing to inform you of an event that may impact the privacy of some of your personal information. We are providing you with information about the event, our response, and information related to what you may do to better protect your information, should you feel it appropriate to do so. If you have any questions, you may contact the toll-free telephone number noted below.

JCCA takes this event and information security very seriously. Following our initial discovery of suspicious activity, we immediately took steps to ensure the security of our systems and investigate the event. Notice of the event was provided to local and national media outlets and posted on our website. We also promptly notified federal law enforcement and relevant regulatory bodies of this event. As part of JCCA's ongoing commitment to the privacy of information in our care, we have implemented additional technical security measures to strengthen the security of our systems. We also have reviewed and enhanced existing data privacy policies and procedures.

As an added precaution we are offering you access to 24 months of credit monitoring and identity theft protection services through Experian at no cost to you. Enrollment instructions are enclosed with this letter. We encourage you to enroll in these services as we are unable to act on your behalf to do so.

If you believe there was fraudulent use of your information as a result of this incident and would like to discuss how you may be able to resolve those issues, please reach out to an Experian agent. If, after discussing your situation with an agent, it is determined that identity restoration support is needed then an Experian Identity Restoration agent is available to work with you to investigate and resolve each incident of fraud that occurred from the date of the incident (including, as appropriate, helping you with contacting credit grantors to dispute charges and close accounts; assisting you in placing a freeze on your credit file with the three major credit bureaus; and assisting you with contacting government agencies to help restore your identity to its proper condition).

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer's name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

- 1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. Addresses for the prior two to five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;

- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
