Mark J. Bronsky, DMD, MS, P.C., d/b/a Bronsky Orthodontics (“Bronsky Ortho” or “we”) is writing to provide you with notice of an event that may involve some of your information. While we are unaware of any misuse of your information at this time, we are providing you with this notice to inform you of the incident, our response, and steps you may take to help protect your information, should you feel it necessary to do so.

What Happened? On October 16, 2025, we detected unusual activity within an employee email account. We immediately took steps to secure our email system and launched an investigation into the activity with the assistance of cybersecurity specialists. The investigation determined a limited number of email accounts were subject to unauthorized access by an unknown actor between approximately August 18 and October 16, 2025. We then conducted a thorough and time-intensive review of the email accounts to identify the information within the accounts and the individuals associated with this information. We also undertook additional review and validation steps to identify and verify information necessary to provide direct notification. As a result of this review, we are now providing this notice to inform you of the incident and describe the steps we are taking in response.

What Information Was Involved? Our investigation determined that the following information may have been involved in this incident:



What We Are Doing. The privacy of patient information is one of our top priorities. As soon as we discovered this incident, we took the measures referenced above. We also implemented enhanced security measures in order to better safeguard all personal information in our possession and to help prevent a similar incident from occurring in the future. We are also reporting this incident to appropriate regulators, including the U.S. Department of Health and Human Services. Additionally, we are providing you with information about steps you can take to help protect your information.

What You Can Do. Please review the enclosed *Steps You Can Take to Protect Your Personal Information*, which contain information on what you can do to protect against the possibility of identity theft and fraud. As a best practice, we also encourage you to remain vigilant against incidents of identity theft by reviewing account statements and explanations of benefits for unusual activity and to report any suspicious activity promptly to your insurance company, health care provider, or financial institution.

STEPS YOU CAN TAKE TO PROTECT PERSONAL INFORMATION

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General. The Federal Trade Commission also encourages those who discover that their information has been misused to file a complaint with them. by way of the contact information listed above. Consumers have the right to file a police report if they ever experience identity theft or fraud. Please note that in order to file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement and the relevant state Attorney General. This notice has not been delayed by law enforcement.

Further, pursuant to the Fair Credit Reporting Act, the consumer reporting bureaus must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to consumers' files is limited; consumers must give consent for credit reports to be provided to employers; consumers may limit "prescreened" offers of credit and insurance based on information in their credit report; and consumers may seek damages from violators. Consumers may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active-duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
