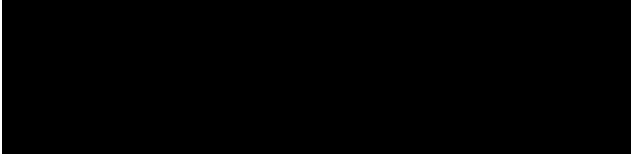

I am writing with important information regarding two recent data security incidents at The Gladney Center for Adoption (“Gladney”). The privacy and security of the protected personal information entrusted to us is of the utmost importance to our organization. As such, we wanted to provide you with information about the incidents, explain the services we are making available to you, and let you know that we continue to take significant measures to protect your information.

What Happened?

Gladney experienced a security incident in or about February 2025 that impacted a portion of our network. As we worked to understand and investigate the impact on personal information stemming from that incident, Gladney identified a separate security incident related to a third-party system vulnerability occurring in or about April 2025 that impacted the same Gladney network section.

What We Are Doing.

Upon learning of these incidents, Gladney commenced a prompt and thorough investigation separately for each. Investigations of this kind take some time, and it was important for Gladney to get it right. As part of our investigation, we have worked closely with external cybersecurity professionals and notified federal law enforcement of the incidents. Additionally, Gladney continues to review our existing policies and training protocols relating to data protection while enhancing security measures and monitoring tools to further mitigate risks of this nature, including but not limited to switching out systems that no longer serve their purpose and comply with our strict data protection measures. We continually evaluate and modify our practices and internal controls to enhance the security and privacy of your protected personal information.

During our investigation, we identified documents that may have been affected. Those documents were then manually reviewed to identify what individuals’ personal information may have been contained within the documents. This is a lengthy process that Gladney worked to expedite as much as possible to identify all potentially affected individuals and begin the notification process. Based on that review, Gladney discovered on January 23, 2026, that certain files containing your personal information may have been subject to unauthorized access or acquisition stemming from both incidents. We want to make you aware of this and provide you with steps you can take to further protect your information.

What Information Was Involved?

The potentially impacted files contained , **but do not believe it included more sensitive information.**

What You Can Do.

**We have no evidence that any of your information has been used for identity theft or to commit financial fraud.** Nevertheless, out of an abundance of caution, we wanted to make you aware of the incident. We are also providing you with complimentary access to identity monitoring for 24 months provided by Kroll. Kroll is a global leader in risk mitigation and response, and their team has extensive experience helping people who have sustained an unintentional exposure of confidential data. Your identity monitoring services include Credit Monitoring, Fraud Consultation, and Identity Theft Restoration.

**1. Take Advantage of Your Identity Monitoring Services**

You have been provided with access to the following services from Kroll:

***Section 1.01 Single Bureau Credit Monitoring***

You will receive alerts when there are changes to your credit data—for instance, when a new line of credit is applied for in your name. If you do not recognize the activity, you'll have the option to call a Kroll fraud specialist, who will be able to help you determine if it is an indicator of identity theft. To receive credit services, you must be over the age of 18 and have established credit in the U.S., have a Social Security number in your name, and have a U.S. residential address associated with your credit file.

***Section 1.02 Fraud Consultation***

You have unlimited access to consultation with a Kroll fraud specialist. Support includes showing you the most effective ways to protect your identity, explaining your rights and protections under the law, assistance with fraud alerts, and interpreting how personal information is accessed and used, including investigating suspicious activity that could be tied to an identity theft event.

***Section 1.03 Identity Theft Restoration***

If you become a victim of identity theft, an experienced Kroll licensed investigator will work on your behalf to resolve related issues. You will have access to a dedicated investigator who understands your issues and can do most of the work for you. Your investigator will be able to dig deep to uncover the scope of the identity theft, and then work to resolve it.

**2. Placing a Fraud Alert.**

Whether or not you choose to use the complimentary credit monitoring services, we recommend that you place an initial 90-day “Fraud Alert” on your credit files, at no charge. A fraud alert tells creditors to contact you personally before they open any new accounts. To place a fraud alert, call any one of the three major credit bureaus at the numbers listed below. As soon as one credit bureau confirms your fraud alert, they will notify the others.

**3. Consider Placing a Security Freeze on Your Credit File.**

If you are very concerned about becoming a victim of fraud or identity theft, you may request a “security freeze” be placed on your credit file at no cost. A security freeze prohibits, with certain specific exceptions, the consumer reporting agencies from releasing your credit report or any information from it without your express authorization. You may place a security freeze on your credit report by sending a request in writing, by mail, to all three nationwide credit reporting companies. In order to place the security freeze, you will need to supply your name, address, date of birth, Social Security number, and other personal information. After receiving your freeze request, each credit reporting company will send you a confirmation letter containing a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

If you do place a security freeze prior to enrolling in the credit monitoring service as described above, you will need to remove the freeze in order to sign up for the credit monitoring service. After you sign up for the credit monitoring service, you may refreeze your credit file.

#### **4. Obtaining a Free Credit Report.**

Under federal law, you are entitled to one free credit report every 12 months from each of the above three major nationwide credit reporting companies. Call **1-877-322-8228** or request your free credit reports online at **www.annualcreditreport.com**. Once you receive your credit reports, review them for discrepancies. Identify any accounts you did not open or inquiries from creditors that you did not authorize. Verify all information is correct. If you have questions or notice incorrect information, contact the credit reporting company.

#### **5. Additional Helpful Resources.**

Even if you do not find any suspicious activity on your initial credit reports, the Federal Trade Commission (FTC) recommends that you check your credit reports periodically. Checking your credit report periodically can help you spot problems and address them quickly.

If you find suspicious activity on your credit reports or have reason to believe your information is being misused, call your local law enforcement agency and file a police report. Be sure to obtain a copy of the police report, as many creditors will want the information it contains to absolve you of the fraudulent debts. You may also file a complaint with the FTC by contacting them on the web at [www.ftc.gov/idtheft](http://www.ftc.gov/idtheft), by phone at 1-877-IDTHEFT (1-877-438-4338) or TTY: 1-866-653-4261, or by mail at Federal Trade Commission, Consumer Response Center, 600 Pennsylvania Avenue, NW, Washington, DC 20580. Your complaint will be added to the FTC's Identity Theft Data Clearinghouse, where it will be accessible to law enforcement for their investigations. In addition, you may obtain information from the FTC about fraud alerts and security freezes.

You may also reach out to the Social Security Administration to notify them of the impact on your Social Security Number. They may be reached via the telephone by contacting the National 800 Number at 1-800-772-1213 between 8:00 a.m. – 7:00 p.m. Eastern Time, Monday through Friday. If you are deaf or hard of hearing and use TTY equipment, you can call the TTY number at 1-800-325-0778.

#### **6. State Specific Information.**
