NOTICE OF [Extra4]

Dear Sample A. Sample:

Alexes Hazen MD, PLLC (“the Practice”) writes to inform you of an event that may involve some of your information. Although we have not received any indication of identity theft or fraud as a result of this event, this notice provides information about the event, our response, and resources available to you to help protect your information from possible misuse, should you feel it is appropriate to do so.

What Happened? The Practice recently concluded its investigation of an incident involving unauthorized access to certain computer systems. Working with third-party cybersecurity specialists and law enforcement authorities, the investigation confirmed that an unauthorized actor gained access to certain Practice computer systems between June 23, 2025, and January 20, 2026, and may have accessed or taken a limited amount of information during that time.

The Practice completed a comprehensive review of the impacted information on May 15, 2026, and is notifying individuals based on the results of this review.

What Information Was Involved? The investigation determined that the following types of information related to you may have been affected: name, [Extra1][Extra2].

What We Are Doing. Please know that we take this event and the security of information in our care very seriously. We aggressively and diligently worked with appropriate resources to investigate this event and enact mitigation steps. This included notification to and cooperation with law enforcement agencies and regulatory bodies. As an added precaution, we are offering you credit monitoring and identity restoration services through Experian for [Extra3] months at no cost to you.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements, explanations of benefits, and monitoring your free credit reports for suspicious activity and to detect errors. Additional information and resources may be found in the enclosed *Steps You Can Take to Protect Your Personal Information*. You may also enroll in the complimentary services available to you. Enrollment instructions are attached to this letter.

Enroll in Monitoring Services

To help protect your identity, we are offering complimentary access to Experian IdentityWorksSM for [Extra3] months.

If you believe there was fraudulent use of your information and would like to discuss how you may be able to resolve those issues, please reach out to an Experian agent. Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
