## Application Process

Applications will be accepted between Monday August 11, 2025, and Monday September 22, 2025. Applicants must apply electronically via the Attorney General's Office Employment and Recruitment Portal by visiting www.mass.gov/ago/fellowship. In addition to a completed application, applicants must submit the following:

- 1. Resume;
- Cover Letter;
- Law School Transcript;
- A one page personal statement.

Your resume will reflect your legal and professional experience. The personal statement should explain the reason(s) for your commitment to public interest law and your interest in the work of the Attorney General's Office, including any personal experiences related to the mission of our office.

Applicants will be asked to upload these documents as part of the application process.

Writing sample and OFFICIAL law school transcript to be provided at time of interview.

Selected candidates will be invited for interviews in October/November 2025. Offers will be extended in December 2025.

## About the Program

The Fellowship Program offers entry-level attorneys the unique opportunity to engage in the practice of law and policy in the largest public sector legal office in the Commonwealth.

The Attorney General's Office serves the public through six core bureaus: Criminal, Energy and Environment, Executive, Government, Health Care and Fair Competition, and Public Protection and Advocacy. Selected fellows will explore and gain experience in a variety of practice areas over the course of the two-year fellowship. Fellows generally complete three rotations through different areas of the office.

Fellows receive training and guidance from experienced attorneys to enhance proficiency and develop skills. Through the Fellowship Program, new attorneys will launch their legal careers by enriching their legal experience, broadening their exposure to the public sector, and assuming substantial individual responsibility for their work.

Fellowship Program candidates will be selected on the basis of several factors, including but not limited to:

- · Academic and intellectual ability;
- Knowledge, experience, and ability in legal areas such as research, writing, advocacy, trial preparation, discovery, investigation, negotiation, etc.;
- Legal, professional, or personal experience related to the mission of the Attorney General's Office;
- Demonstrated engagement and leadership in school and/or community activities;
- Law journal participation or other experience in writing/editing;
- Flexibility and interest in a variety of legal subject areas.

The successful candidate will be able to demonstrate a commitment to public interest law, a connection to the people and communities we serve, and an interest in supporting a respectful and inclusive work environment.

#### Eligible Candidates

The Attorney General's Office seeks applications for its Fellowship Program from:

- Third-year day or fourth-year evening law students scheduled to graduate in 2026; and
- Current full-time judicial law clerks who received their J.D. prior to 2026 and were either:
  - Accepted into their clerkship(s) straight from law school; or
  - 2. Accepted and deferred for up to one year and did not practice as an attorney before beginning their clerkship(s).

The Fellowship Program begins in September 2026. All individuals invited to participate must commit to a two-year term and must take the bar exam in Massachusetts no later than July 2026. Additionally, individuals must be admitted to the bar before the start of their second-year rotation.

#### Additional Information

The salary will be \$78,000 per year. Fellows will have the opportunity during their final rotation to seek continued employment with the Attorney General's Office.
