# Notice of Funding Opportunity (NOFO)

Funding for this Notice of Funding Opportunity (NOFO) comes from the 2023-2024 HMEP award to MEMA. The total federal award amount is \$279,037; federal period of performance 10/1/2023 thru 9/30/2024; CFDA #20.703.

MEMA has allocated an estimated \$127,231 for these pass-through subgrants to eligible Local and Regional Emergency Planning Committees (LEPC/REPC).

## Overview and Purpose of HMEP

The purpose of the HMEP grant program is to protect against the risks to life, property, and the environment that are inherent in the transportation of hazardous material in intrastate, interstate, and foreign commerce (Title 49 U.S.C. § 5101). The HMEP grant supports the emergency preparedness and response efforts of States, federally recognized Tribes, and Territories that deal with hazardous materials emergencies, specifically those involving transportation. This grant also aids in meeting the requirements of Title 42 U.S.C. Chapter 116 §§ 301 and 303.

- Funding may be used to support hazardous material related activities in the following categories:
  - Planning
  - Training
  - Exercises

MEMA's Hazardous Material Emergency Preparedness (HMEP) subgrant program provides funds to assist Local and Regional Emergency Planning Committees (EPCs) to "develop, improve, and carry out emergency plans" within the National Response System and the Emergency Planning and Community Right-To-Know Act (EPCRA) of 1986.

## HMEP is not an operational grant

Funding may only be used to support hazardous material PLANNING, TRAINING, and EXERCISE related activities. Operational supplies and equipment are not eligible

# Cost Share / Match

HMEP has a cost share / match requirement of 20%, however MEMA currently does not pass this match requirement on to Local / Regional Emergency Response Committees subgrants.

## SERC Certification / SERC Registration

The State Emergency Response Commission (SERC) has **REPLACED** Emergency Planning Committees (EPCs) Certification with SERC Registration.

EPC must be registered with the SERC as a condition of eligibility to apply for HMEP grant funds.

## SERC / HMEP Priorities

#### SERC has set the following priorities for 23-24 HMEP:

- 1. Planning
- 2. Exercises
- 3. Training
- 4. Conferences

# 23-24 HMEP Subgrants

HMEP is a competitive subgrant open to all LEPC/REPCs that are registered with SERC

Funding is capped: \$5,000 per LEPC (single community) \$10,000 per REPC (multi-communities)

As a condition of award, LEPC/REPC will be required to submit their most recent version of their Hazardous Material Emergency Response Plan to the SERC for review

#### Priority #1 Planning Max Points 10

**EPCRA Compliance HazMat Plans** 

Developing, improving and implementing emergency plans required under the Emergency Planning and Community Right-to-Know Act of 1986 (EPCRA)

- Hire planning consultant/contractor
- Plan development
- Risk and Capability assessments
- GIS mapping services
- Commodity flow studies
- supplies, equipment, food, drinks, backfill, and/or overtime will not be allowed under this priority
- If your LEPC/REPC does not have a plan this would be the only project you would be eligible to apply for

### Priority #2 Exercises Max points 6

#### HazMat Transportation Related Exercises

- Discussion-Based
  - Seminars
  - Workshops
  - Tabletop
  - Games
- Operations-Based
  - Drills
  - Functional
  - Full-scale

#### Priority #2 – Exercises, cont.

- All exercises must be based on a HazMat transportation related incident
- Food / drinks will not be allowed
- · Laptops, general office supplies, etc. will not be allowed
- Gas meters to be considered only if requested for a full-scale exercise
- Backfill / Overtime for exercise participants must be clearly justified
- If LEPC/REPC does not have a HazMat plan and/or HazMat plan has not been updated within the past 3-years, you will only be eligible to conduct a discussion-based exercise
- After-Action Reports will be required with your reimbursement request
- Exercises that are not HazMat transportation related will not be eligible
- As a condition of award, LEPC/REPC will be required to submit their most recent updated hazmat emergency response plan to the SERC for review

#### Priority #3 Training Max points 4

#### **Certification Training**

- HazMat Awareness
- Operations
- Technician
- Specialist
- Refreshers

#### **Noncertified Training**

- HazMat ICS 100, 200, 300, 400
- Chemistry for Emergency responders
- Flammable Liquid/Gas Bulk storage
- Surveying HazMat Incidents
- Level A/B Personnel Protective
- HazMat for Dispatchers

## Priority #3 – Training, cont.

- If LEPC/REPC does not have a HazMat plan or plan has not been updated within the past 3-years you will only be eligible for Certification training courses
- Certification courses offered at conferences will only qualify under priority #4 Conferences
- Food / drinks will not be allowed

### Priority #4 Conferences Max points 2

#### **Conference Attendance**

- MA HazMat Tech (MAHMT) Conf
- International Assoc of Fire Chiefs (IAFC)
- Hot Zone
- Hazmat Continuing Challenge

# Priority #4 – Conference (cont.)

- Allowable Expenses include:
  - Conference Registration
  - Travel to/from conference
  - Per diem (in accordance with local travel policies, not to exceed GSA rates)
- Unallowable Expenses include:
  - Backfill / Overtime
- > LEPC/REPCs not eligible for conference attendance if they do not have a hazmat plan
- > Certification courses offered at conferences will only qualify under priority #4

# Additional Scoring Criteria

Applies to both LPEC and REPC applications:

- Application clearly defined their risk assessment process (max points 10)
- As a result of their risk assessment, application clearly defined community(ies) gaps and needs (max points 10)
- SVI Communities\* (max points 10)
- The proposed project/activity clearly explains how it will fill their community(ies) identified gaps/needs (max points 8)
- Clear understanding of how the proposed project/activity will enhance community(ies) (max points 6)
- Budget completed properly and matches narrative descriptions (max points 4)

\*LEPC/REPCs with SVI communities will be required to describe how their proposed project will benefit their vulnerable populations and define how their project will lessen the effects on them during emergencies and disasters. Those applications that do not address this may result in zero (0) points even though they are an SVI community.

## **Application Notes**

- This is a competitive subgrant
  - Your application must be complete, there will not be any follow up to get further information or to clarify what vou mean.
  - Your project descriptions must be detailed enough for reviews to compare your needs against all other applications submitted
  - We will not be able to review and comment on draft applications
- Details regarding allowable expense are listed in the NOFO
   Unallowable items/expenses will be removed from application prior to being scored
- Website/brochure required if purchasing supplies, equipment and/or attending conference
  This requirement does not apply to contractor/consultant services
  If website is not available, you must submit/attach brochure(s) which provides project details & photos.
  Applications submitted without product/vendor website and/or brochure, if required, will be considered incomplete applications, and will not be scored or funded.
- Applications must be emailed to <u>EM.Grants@mass.gov</u>
   It is the LEPC/REPC responsibility to get their application submitted to the EM Grants Unit by the application due date
  - Applications received after 10/31/2023 will not be reviewed, scored, or considered for funding

## **Application Submission Process**

Complete your application and email it back to the EM Grants Unit at <u>EM.Grants@mass.gov</u>

- Applications must be received by the EM Grants Unit no later than 10/31/2023
   Application due date, 10/31/2023, is a hard date (no extensions)
  - > Applications received after this date will **not** be reviewed, scored, or considered for funding
- EM Grants Unit will provide confirmation once your application has been received
- Eligible applications will be reviewed and scored by a review panel
- Those applications with the highest score will be recommended for funding

Everyone will be notified (funded or not) once the review/score process has been completed

If your project has been selected for funding, you will receive an email with you contract documentation to be signed and mailed (originals) back to the EM Grants Unit.

## Competitive subgrant

- As stated earlier, this is a competitive subgrant.
- Applications will be scored as submitted and those with the highest scores will be funded.
- If awarded, you will not be allowed to revise your project.
