An Initiative Petition for An Act Preserving Local Control of Zoning

We, the undersigned, hereby propose the following as an initiative petition law under Article 48, as amended, of the State Constitution:

An Act Preserving Local Control of Zoning

Be it enacted by the People, and by their authority,

An Act Preserving Local Control of Zoning

Section 1 -- It is hereby declared the policy of the Commonwealth that zoning and land use control is, generally, a matter of local control vested primarily, if not exclusively, in municipal control. This policy accords with the Home Rule Amendment, Article 89 of the Amendments to the State Constitution, and the long standing tradition of local control

Section 2 -- With specific exception for Chapter 40B ss. 20-23, the State Government shall not compel, coerce, incentivize, or otherwise try to induce municipalities to adopt or fail to adopt zoning policies.

Section 3 -- Any existing provisions of law, contrary to Section 2, are hereby repealed
