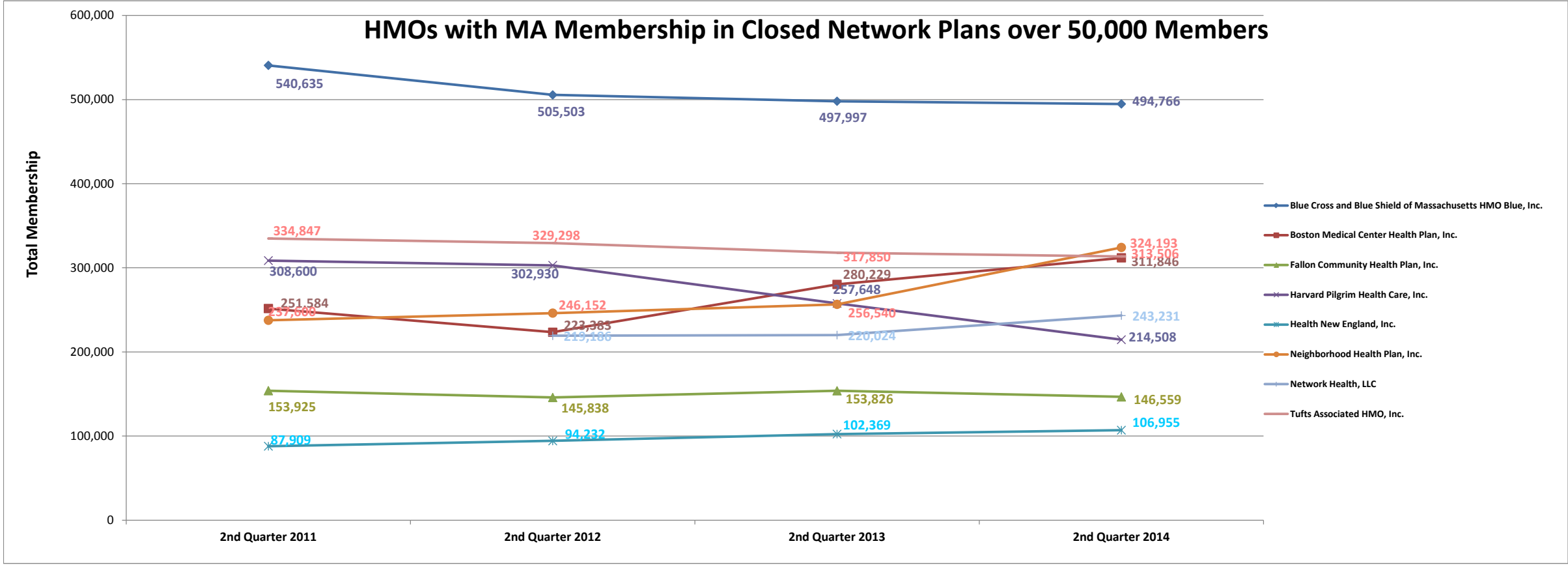

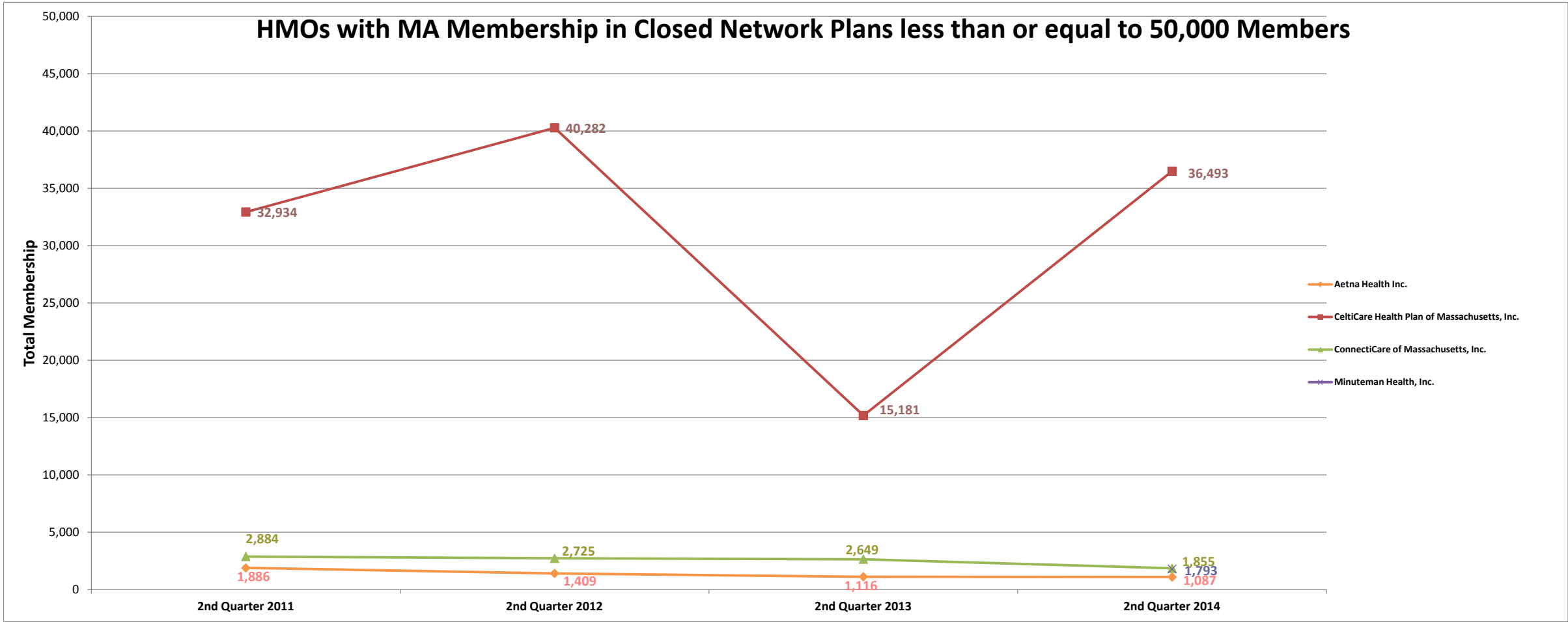
COMPARISON OF 2ND QUARTER MEMBERSHIP TO LAST THREE 2ND QUARTERS



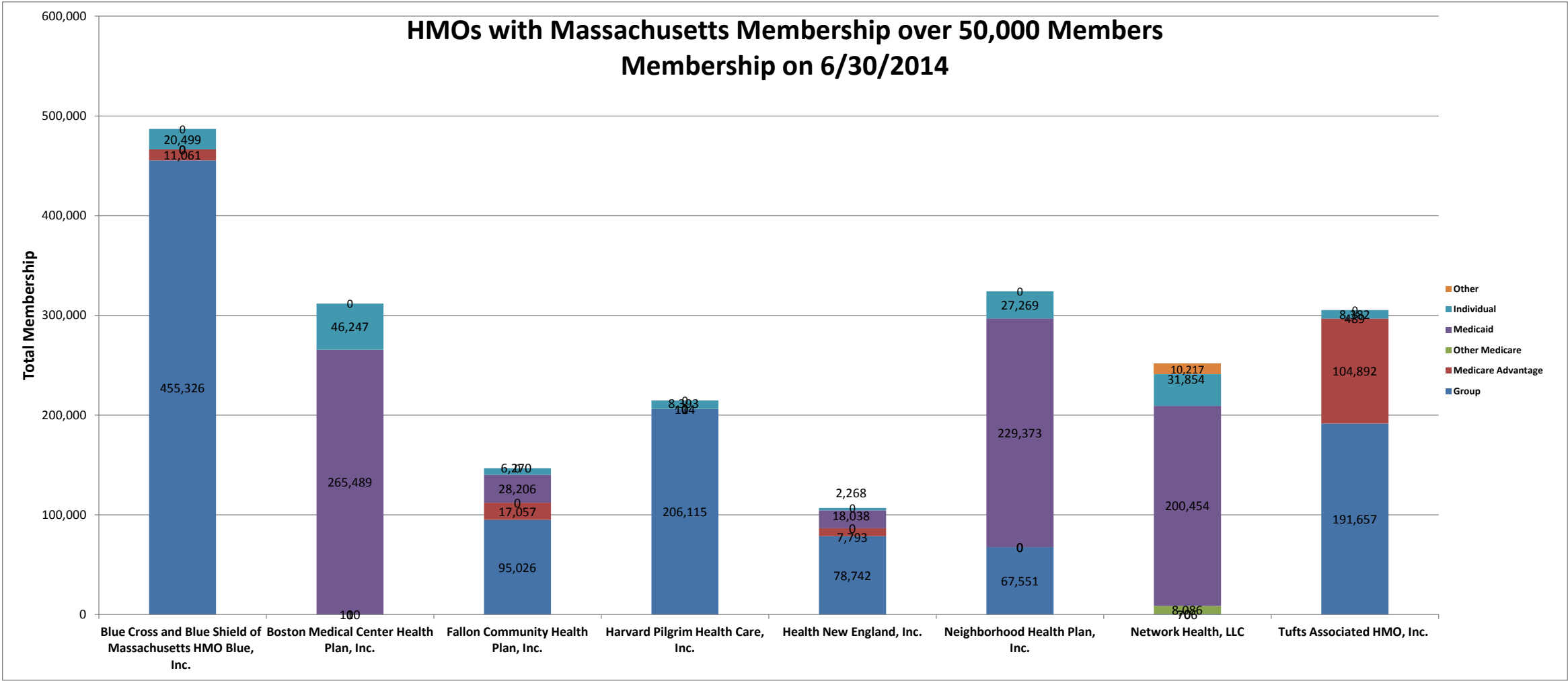

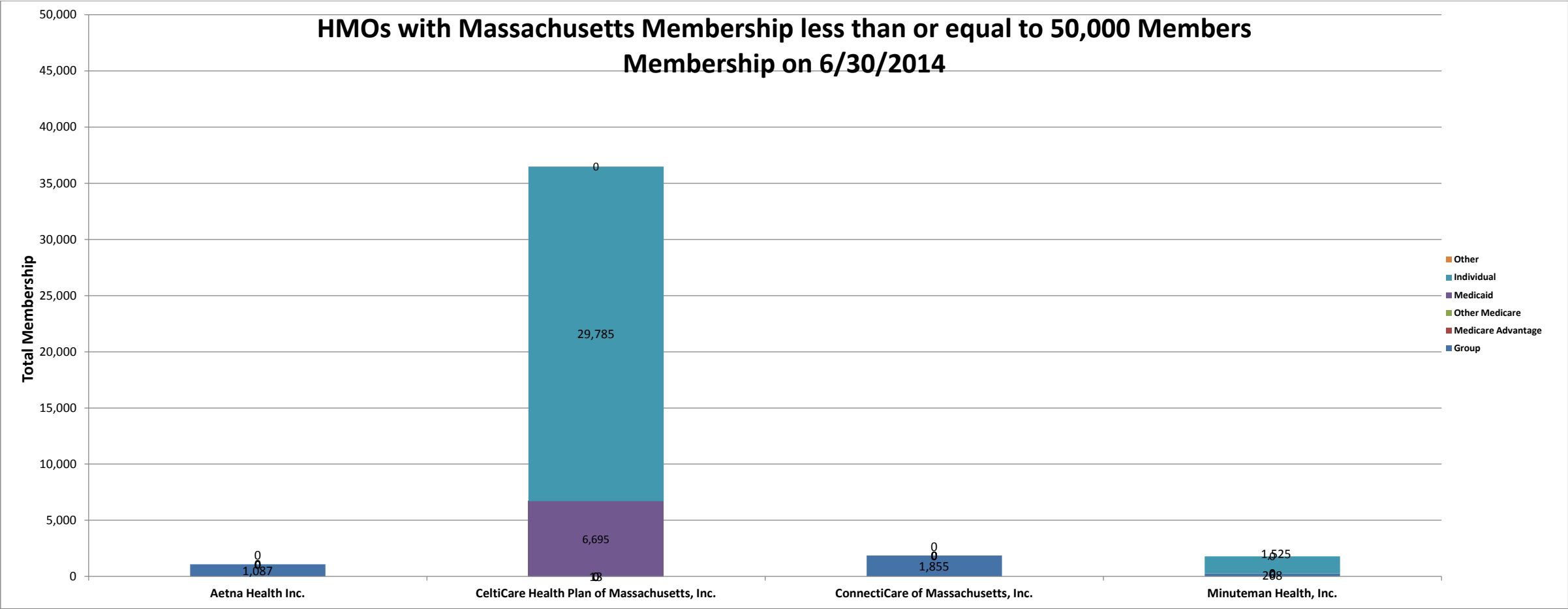
COMPARISON OF 2ND QUARTER MEMBERSHIP TO LAST THREE SECOND QUARTERS

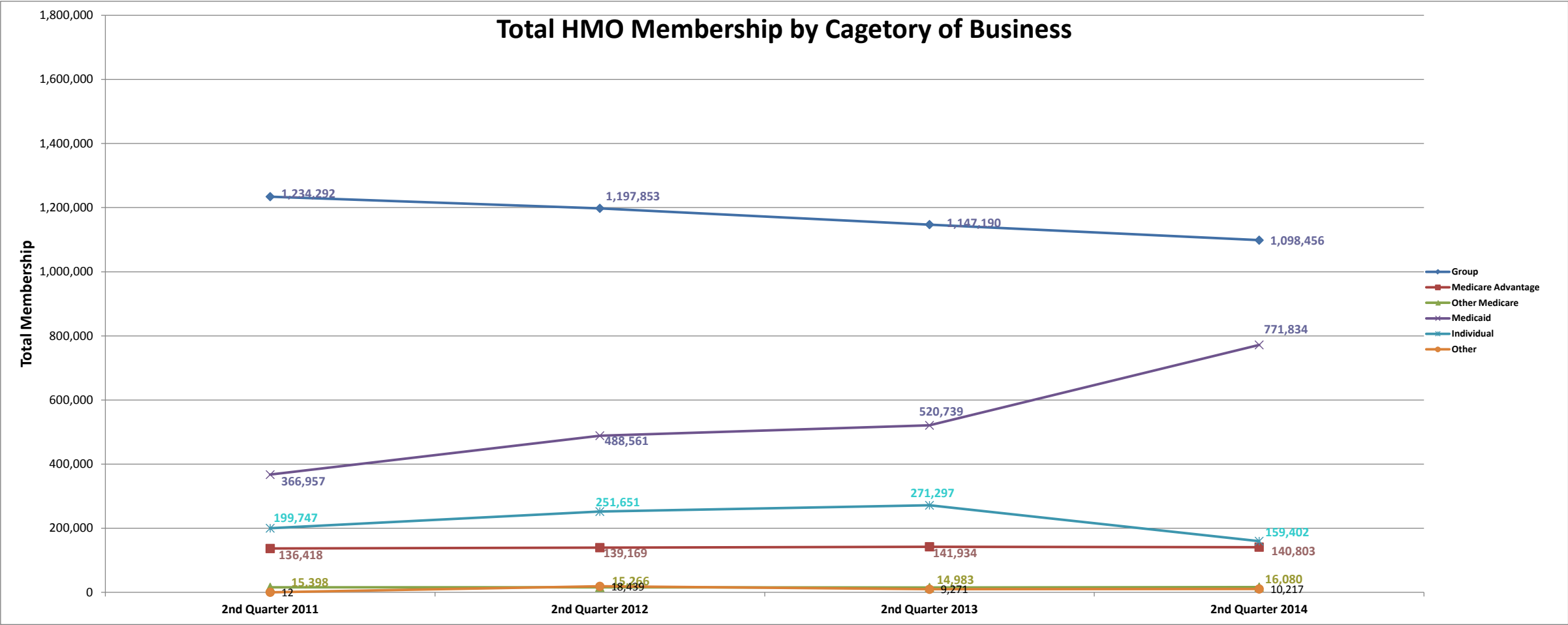

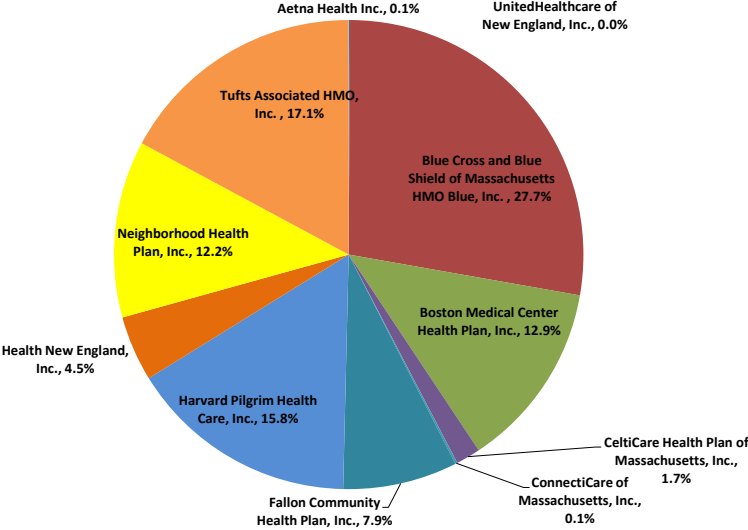

COMPARISON OF 2ND QUARTER MEMBERSHIP TO LAST THREE QUARTERS

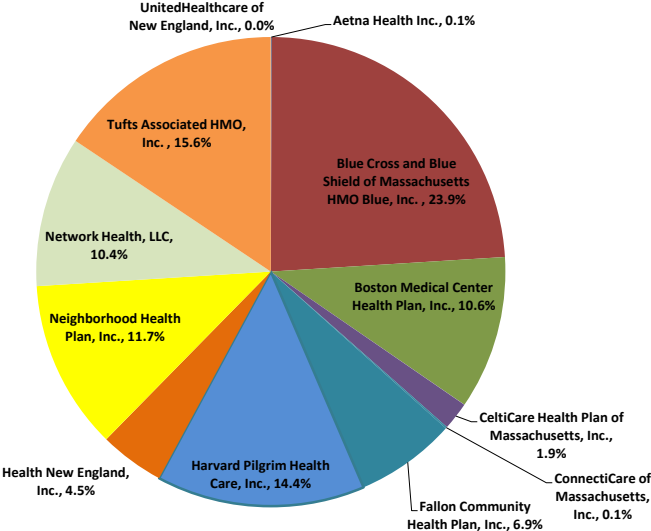

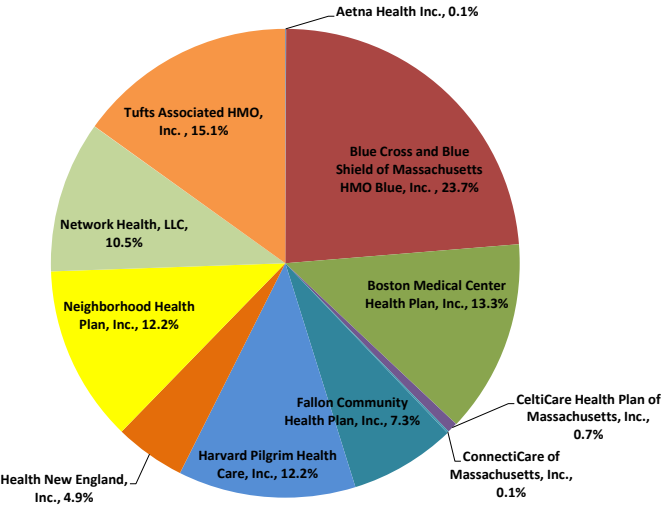
2nd Quarter 2011 Share of Massachusetts HMO Market



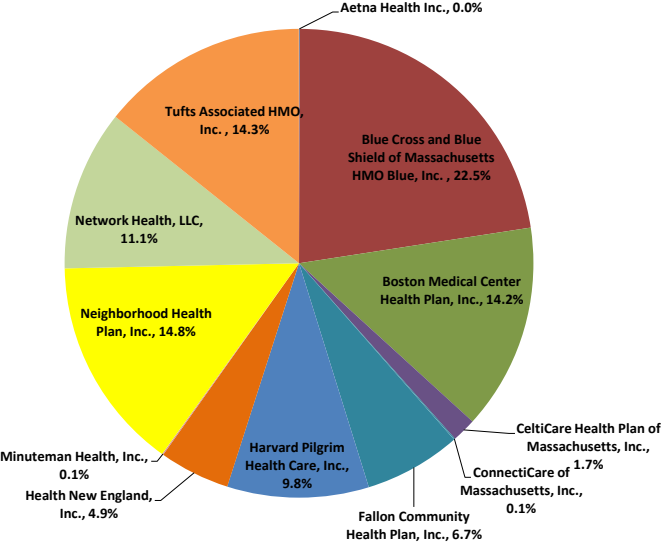
2nd Quarter 2012 Share of Massachusetts HMO Market
