Ladies & Gentlemen:

In accordance with Chapter 130, Section 74A of the Massachusetts General Laws, the Division of Marine Fisheries has re-examined the waters of Extended Anchorage Mooring Area (V11.10), in the Town of Tisbury, classified as "CONDITIONALLY APPROVED" and in the "Closed to Shellfishing" status based on NSSP mooring area criteria. As a result of this examination, the Division has determined that the below-defined area no longer meets the established criteria for the harvest of shellfish and has changed the status to "**Closed to Shellfishing**" as of sunrise on April 3, 2025.

Therefore, under authority of Massachusetts General Laws, Chapter 130, Section 74A, the status of the below defined area will be changed to "**Closed to Shellfishing**" to the taking of all shellfish. Digging, harvesting, or collecting and/or attempting to dig, harvest or collect shellfish and the possession of shellfish from the below defined area is prohibited.

Under authority of 322 CMR 7.01(7) all permits issued thereunder are hereby conditioned to prohibit the taking, selling or possession of shellfish from the below defined area.

"The waters and flats of Lagoon Pond in the Town of Tisbury, west of the Tisbury/Oak Bluffs town line and bounded by the following coordinates: 41.44442°, -70.59307°, 41.44178°, -70.59555°, 41.44236°, -70.59750°, 41.44515°, -70.59469°."

The preceding "CONDITIONALLY APPROVED" area shall remain in the closed status during the inclusive dates. The status will not automatically revert to Open to Shellfishing on November 1, 2025, but will remain closed until examined by the Division and notification is made that the area has been placed in the open status.
