CHAPTER TITLE:	Professional Employer Oranization Registration Regulation

SUMMARY OF REGULATION: State the general requirements and purposes of this regulation.

454 CMR 30.00 shall be a new regulation. Recently enacted legislation (M.G.L. c. 149, sec.s 192-203) requires that businesses providing professional employer services for client companies, commonly known as PEOs, to register with the DLS and it requires DLS to promulgate regulations to establish the process, fee, and incidentals of registration. This regulation will require PEOs providing outsourced human resource tasks will be adequately financed, bonded, inspected and in compliance with the new statutory requirements. The regulation establishes an annual registration fee of \$500 and requires that PEOs maintain their business records and submit to inspections by DLS.
