#### **Reminder: ASMFC Public Hearing on Lobster Addendum XXXII Scheduled for April 10 at 6PM**

The Atlantic States Marine Fisheries Commission (ASMFC) is seeking public comment on [Addendum XXXII](#) to the Interstate Fishery Management Plan (FMP) for American Lobster. The Addendum considers repealing all Addendum XXVII measures pertaining to carapace size and escape vent size limits. If approved, the new addendum will supersede Addendum XXVII before its implementation date, resulting in DMF taking an action to rescind existing state regulations that increase the minimum carapace size and escape vent size for Lobster Conservation Management Area (LCMA) 1 and the Gulf of Maine Recreational Lobster Area and decrease the maximum carapace size for the Outer Cape Cod LCMA, LCMA 3, and the Outer Cape Cod Recreational Lobster Area.
