TRAVEL TIME

Labor Charges accrue from warehouse to warehouse with a 3 h minimum charge. 617 Boston Movers LLC will make every reasonable effort to determine the correct distance between warehouse and pickup point, pickup point and drop off point and back from the drop off point to the warehouse by the shortest practical truck route.

MINIMUM CHARGE

617 Boston Movers LLC will require a minimum of 3 h charge for each move. Once the 3 h minimum charge is satisfied, charges accrue pro-rated to the quarter hour.

PAYMENTS
