I. Call to Order

Mr. Wilkinson, Board Chair, called the meeting to order at 9:06 a.m.

Mr. Wilkinson welcomed all the attendees to the first meeting of the Board of Certification

of Community Health Workers (BOCCHW). Board members, DPHL staff, and the members of the public introduced themselves.

#### IV. Greetings

Dr. Madeleine Biondolillo, Director of DPH's Bureau of Health Care Safety and Quality, acknowledged the contributions of both the Board members and the CHW profession and addressed the important role that CHWs play in ensuring equal access to healthcare in Massachusetts.

Dr. Biondolillo presented citations from Governor Deval Patrick and DPH Commissioner John Auerbach to Lisa Renee Holderby-Fox, Executive Director and members of the Board of the Massachusetts Association of Community Health Workers (MACHW) for MACHW's commitment to public health and the advancement of the community health worker profession.

#### V. <u>Community Health Worker Definition</u>

Gail Hirsch, Director of DPH's Office of Community Health Workers, presented an overview of the development of the definition of "community health worker" contained in Board's statutes. Following Ms. Hirsch's presentation, Mr. Wilkinson solicited comments on the statutory definition of CHW.

### VI. Board Statutes: Chapter 322 of the Acts of 2010

Ms. Stein reviewed the Board's statutes, M.G.L. c. 13, §§ 106-108 and M.G.L. c. 112, §§ 259-262; presented an overview of the administrative rulemaking process; and distributed a tentative regulations outline.
