Re: MelroseWakefield Healthcare, Inc. - Closure of Inpatient Psychiatric Beds

Dear Mr. Davis:

This letter is submitted on behalf of MelroseWakefield Healthcare, Inc. (“Hospital”) regarding its inpatient psychiatric services located at its campuses in Melrose and Medford. The Hospital is a member of Tufts Medicine and operates two campuses that provide inpatient psychiatric services in a total of 58 beds. Adult inpatient psychiatric services are provided in 24 beds at the main campus located at 585 Lebanon Street in Melrose. Inpatient geriatric psychiatry services are provided in 34 beds at the Lawrence Memorial Hospital campus located at 170 Governors Avenue in Medford. The closure of these beds will allow Tufts Medicine to improve and expand access to care at a new inpatient psychiatric hospital in Malden. Pursuant to 105 CMR 130.122, the Hospital hereby informs the Department of Public Health that it will close its inpatient psychiatric beds on March 31, 2026.

In compliance with applicable requirements at 105 CMR 130.122(B), the Hospital provides this written notice of the planned discontinuance of the services noted above. The following information regarding the closure is hereby provided for your review:

**2. A description of the anticipated impact on individuals in the Hospital's service area following the closure of the beds.**

In February 2026, Acadia Healthcare Company and Tufts Medicine will open Tufts Medicine Behavioral Health Hospital, a 144-bed inpatient behavioral health hospital licensed by the Department of Mental Health. The new hospital is located at 100 Hospital Road in Malden and will provide access to same service area currently served by the Hospital. When fully operational, the new hospital will have 72 adult beds, 48 geriatric beds and 24 adolescent beds. Moreover, the new hospital's additional 86 beds will meet a need for more behavioral health capacity in the Commonwealth.

The Hospital will close its inpatient psychiatric beds on March 31, 2026, providing time for the new hospital to open and begin admitting patients before the Hospital's beds are closed. Prior to the closure, the Hospital will complete discharge planning for all patients in collaboration with patients and caregivers. All patients will be discharged and transitioned to the appropriate level of care for the patient's ongoing needs. Through these activities, the Hospital will ensure that current patients are discharged to the appropriate setting prior to closure.

**3. Date for the closure of the beds.**

The date of the closure is March 31, 2026.
