Ladies and Gentlemen,

In accordance with Chapter 130, section 74A of the Massachusetts General Laws, the Division of Marine Fisheries has determined that Wellfleet Inner Harbor (CCB:13.0), in the Town of Wellfleet, closed at 8 am on September 2, 2021, due to the remnants of Hurricane “Ida”, will meet the National Shellfish Sanitation Program guidelines for an “OPEN” status.

Therefore, under authority of MGL, Chapter 130, Sections 74A and 322 CMR 7.01 (7) the below-defined area will revert to its former status prior to the closure of 8 am on September 2, 2021, **effective at 10:30 am on Friday September 10, 2021.**

Those areas previously classified as “APPROVED” and in the “OPEN” status prior to the 8 am on September 2, 2021, shellfish closure will revert to their previous status at 10:30 am on September 10, 2021, and open to the harvest of shellfish for direct human consumption subject to local rules and regulations under authority of MGL Chapter 130, section 52.

“The waters and flats of that portion of Wellfleet Inner Harbor south of a line drawn from the candy-striped pole at the southeastern corner of Town Pier to the candy-striped pole at the Camp Marvel boat house (41.9302833,-70.0230333), south of a line drawn southeasterly from the candy-striped pole at the southeastern corner of the L-Pier to candy-striped pole at the southeastern corner of Town Pier, east of a line drawn from Indian Neck Breakwater to southwestern corner of the L shaped pier and excluding CCB:13.6.”
