Subject: NOTICE OF DISCONTINUATION OF UNBUNDLED NETWORK ELEMENTS

This letter provides the additional information that was referenced in Verizon's May 18, 2004 letter (distributed in all Verizon East states except Pennsylvania) and Verizon's June 8, 2004 letter (distributed in Pennsylvania) which provided formal notice that after August 22, 2004 and September 9, 2004, respectively, Verizon will no longer provide, under Section 251(c)(3) of the Communications Act, either: (i) unbundled Enterprise Switching, whether alone or in combination with any other network element (e.g., combinations of Enterprise Switching and DS-1 or above capacity loops, referred to herein as "Enterprise UNE-P"), or (ii) unbundled shared transport for use with Enterprise Switching. Neither this letter nor the May 18 and June 8 letters addresses unbundled local circuit switching, unbundled network element platform, or associated shared transport provided to mass market customers (i.e., below four lines).

The additional information is a listing of the surcharges (Attachment 1) referenced in the May 18, 2004 and June 15, 2004 letters:

"Verizon is prepared to work with your company to migrate its existing Enterprise UNE-P arrangements to suitable alternative services (such as resale or an alternative commercial arrangement) prior to August 22, 2004. Should your company fail to migrate its Enterprise UNE-P service arrangements to an alternative service on or before that date, Verizon will begin billing any Enterprise UNE-P arrangements that remain in place after August 22, 2004 at a rate equivalent to the Section 251(c)(4) resale rate for business service applicable in that jurisdiction in order to avoid service disruption. The new rate will be effected by means of a surcharge that will be added to the applicable Enterprise UNE-P rates. Additional information about this surcharge will be forwarded to your company shortly. If your company prefers not to pay the resale equivalent rates, your company may of course terminate any Enterprise UNE-P service arrangements through existing disconnect processes."

The surcharges shown in Attachment 1 will be effected by raising the UNE Port monthly recurring rate by the amounts specified in the attachment.

Also as a reminder, Verizon is prepared to enter into commercial negotiations for alternative service arrangements that may offer certain advantages over resale under Section 251(c)(4) of the Act. If you have not already done so, please provide any such written support you wish to offer to Mr. Michael Tinyk at the address shown above. Unless valid written support is received by Verizon, Verizon will give effect to the foregoing notice after August 22, 2004 (September 9, 2004 for Pennsylvania).
