## MASSACHUSETTS COMMISSION ON THE STATUS OF WOMEN

MCSW is an independent state agency legislatively created in 1998 to advance women of the Commonwealth to full equality in all areas of life. The mission of the MCSW is to provide a permanent, effective voice for the women of the Commonwealth. The Commission acts as a liaison to the state government, reviews and reports on the status of women in the Commonwealth, and acts as an advisor to executive and legislative bodies regarding the effect of proposed legislation impacting women

The Commission consists of 19 female volunteers from across the Commonwealth of Massachusetts. The Commissioners are appointed by the Governor, the Speaker of the House of Representatives, the Senate President, and the Caucus of Women Legislators. Commissioners are selected in a way that reflects the racial, ethnic, religious, age, sexual orientation and socioeconomic diversity of Massachusetts.

MCSW is charged with identifying and recommending qualified women for positions at all levels of government, including boards and commissions. To increase women's participation in government, the Commission first produced this publication in 2003. Now in its fourth printing, this revised edition offers information and guidance regarding involvement with Massachusetts boards and commissions, along with a detailed list of boards and commissions in the Commonwealth listed in the Appendix. Lists of local boards and commissions in Massachusetts cities and towns can be accessed through city or town halls or through local city and town websites.

While one woman can make significant contributions to a board or commission through her membership, a larger number of female members increase the likelihood that women's voices are heard and a variety of ideas are considered. Board and commission policies and decisions should reflect the diversity of our communities. If women are underrepresented, the notion that males are superior leaders and decision makers may be entrenched in the ethos of the board or commission.<sup>2</sup> Women's voices deserve to be heard and will ultimately lead to equitable representation and better policy.

What are Boards and Commissions?

Boards and commiss

Boards and commissions are governmental bodies designed to work with state agencies to give a voice to citizens. These organizations allow citizens to be actively involved in their government and offer opportunities to influence decisions that affect the quality of life of Massachusetts residents. Boards set standards and agendas for governing bodies, and commissions act as advisors to local and state legislative bodies. Boards of directors assist management in explicating business strategies and defining objectives. Members of these organizations are typically unpaid, but may be reimbursed for travel expenses.

The appendix of this booklet is alphabetized by subject, excluding prefixes such as 'Massachusetts' and 'Board of'. Each listing contains the web site (if it exists), mailing address, telephone number, and oversight agency. The oversight agency is not necessarily the point of authority but is included to provide context.

### WHAT ARE THE QUALIFICATIONS?

Boards and commissions are a good way for Massachusetts citizens to be involved in their own government. A person will be appointed if they exhibit a skill, interest, or experience in a certain field. Certain boards and commissions are required by law to have members with a specific skill set, political affiliation, or professional background but most of these organizations do reserve seats for citizens looking to get involved. The best way to learn about membership qualifications for a particular board or commission is to visit the http://www.mass.gov/ website for additional information.

In accordance with Governor Patrick's efforts to maintain government transparency and promote civic engagement opportunities, his team launched a website that lists the Boards and Commissions to which he makes appointments. The website is accessible and allows citizens to apply for vacant positions online by uploading their resume and cover letter. To view this search engine, please visit http://appointments.state.ma. us/Default.aspx. It is important to note that this search engine only includes information regarding boards and commissions to which the Governor is the appointing authority. Information found on the Governor's database is also included in the Appendix at the back of this booklet.

### GETTING INVOLVED: THE APPLICATION PROCESS

There are a few important steps to get involved with a board or commission at the local or state level:

- Determine which issues you care about (i.e. civil rights, educational standards, criminal justice standards) and then peruse the full list of boards and commissions included in the Appendix.
- Conduct research on the board or commission of your choice. Read about the purpose of the organization, attend an event they are hosting, and reach out to current members of the organization.
- Ask questions. You will want to know:
  - How many members serve?
  - What are the necessary qualifications for members?
  - What are the duties of a board member or commissioner?
  - What are the priorities of the organization itself?
- Compile your application packet. This includes:
  - A cover letter. Include why you are applying for the position and why you are qualified for this role.
  - A resume. Depending on the organization, a resume may need to be tailored to suit the desired position. It is not necessary to include information regarding every previous position held. Instead, highlight qualifications that are most relevant to the organization to which you are applying.
  - Letters of recommendation. These may not be required;

however it is important to have a few should they be requested.

A list of references. References should include contact information for people who may speak on your behalf regarding your professional qualifications and skills.

### GETTING INVOLVED: THE APPOINTMENT PROCESS

Generally speaking, the appointment process for boards and commissions involves two steps:

nomination and confirmation. The appointing authority (i.e. Governor, Attorney General, Treasury) will make a nomination.

interesting, well-connected individuals, commissions have given me the opportunity to learn about both business and the reality of other people's lives.

or a separate party will make a nomination to be confirmed by the appointing authority. Be sure to check and see how many appointing authorities exist for a given board or commission, because some will have multiple appointing authorities.4 It is important to understand the appointment process and to be aware of the appropriate appointing authorities. Send an application packet to the appropriate appointing authority, and follow-up by contacting the appointing authority to ensure receipt of application materials. This demonstrates initiative and personal

interest. It would also be beneficial to reach out to people who can speak with the proper appointing authority on your behalf. If appointed, members will receive confirmation papers. Be sure to send thank you notes to those who assisted in your appointment, including the appropriate nominating party.

Whether you are appointed or not, exposure to the political process and local governments is an important and valuable experience. While waiting for seats to become vacant, continue to stay involved

with the organization, expand your networks, and continue to develop your professional skills. Finally, be sure to encourage others to apply for positions and get involved.

#### WHY PARTICIPATE?

There are many reasons to seek out membership on a board or commission, either within your hometown or at the state level. Appointment to a board or commission is an opportunity to:

 Influence public policy and engage in civic life based on your interests. Joanne McCrea, a MCSW Commissioner and Salem Historical Commissioner comments, "I have always had an interest in history. It was my major in college and was part of the reason I chose to move to Salem. So serving can be a

- career, but for me, it is also avocation."5
- Ensure that women's voices are heard throughout the Commonwealth. Female membership on boards and commissions will bring gender equity to decision making, and will guarantee that multiple perspectives are acknowledged and considered. A balanced ratio of males and females broadens the scope of the organization to serve more citizens. Homogenous groups will offer homogenous solutions to problems, while inclusive, favorable solutions will result from a heterogeneous board.6
- Be a positive role model for other women and young girls interested in engaging in policy reform, community development, and politics. Women in visible authority positions who triumph in their field will serve to advance society's
