### **FINAL DECISION**

Daniel P. Sieger, Assistant Secretary for Environment at the Massachusetts Executive Office of Energy and Environmental Affairs, has designated me as the Final Decision-Maker in this appeal because MassDEP Commissioner Martin J. Suuberg has recused himself as the Final Decision-Maker.

As a result of my designation as Final Decision-Maker in this appeal, I have reviewed the attached Administrative Consent Order with Penalty and Notice of Noncompliance signed on November 15, 2017 by Ronald C. High, Jr., Managing Member of A-Plus Waste & Recycling, LLC, and on November 15, 2017 by Millie Garcia-Serrano, Regional Director for the Department (00003579).

MassDEP issues this Final Decision incorporating the Administrative Consent Order with Penalty. The petitioner is ordered to pay a civil administrative penalty of six thousand dollars (\$6,000) in accordance with paragraphs 13 and 21 of the Administrative Consent Order with Penalty. Under the terms of 310 CMR 1.01(8)(c), this proceeding is dismissed with the parties


