JD opened the meeting for Roll Call: CS, MK, PM, EM, DR, AJ

 - DR wants future minutes to include more information
 - Table minutes discussion

10:16 AM Discussion of ADA/AAB formatting

- DR discusses challenges of wordsmithing/process
- CS: what will final document be called?
- DR discusses various accessibility standards (Texas, ADA, etc)
- JD discusses AAB format
- CS discusses maintenance feature of ground and floor surfaces
- CS discusses slip resistance issue with cobblestone surfaces
- MK discusses access issues with cobblestone, woodchips, etc
- JD brings discussion back to formatting of new regs
- JP: will investigate including Advisory Opinions in new regs

- DR: option for standalone section of previous advisory opinions?
- CS: broaden the 'maintenance' wording of section 3
- WJ reminds everyone there is a broader maintenance requirement in new regs
- JD wants to streamline how the subcommittee deals with each section
- AJ comments on formatting of AAB vs ADA, if we're going to do lists then we might do numbers instead of sub-letters, protruding objects and circulation path
- JP references Advisory Opinions and per the reading of the rules from the Commonwealth, suggests advisory opinions should not be included in the regulations themselves
- JD: next steps discussion
- WJ: we will refer to the manual style that we must use, bullets vs paragraphs are also for Complaint notices
- DR: take ADA sentences and convert them into a list if need be, AAB should use ADA language, questions about funding for this project, suggests taking public comments on ADA standards,
- WJ: No funding for this project, discussion of previous public comments
- PM agrees with bullets vs letters, question for 302.3 grating for elevators, 304.2: 1:48 vs a percentage
- Discussion about percentages of slope
- CS: most public comments were about inconsistencies between ADA and AAB versions
- WJ: the previous subcommittee has already completed the work of harmonizing the two versions
- DR: when language is the same, adopt ADA language
- CS: when language is the same, adopt AAB language
- WJ discusses substantiative differences between two versions and how there aren't that many, its mostly wordsmithing

- CS does not want to defer wordsmithing to one person, does not want to defer to ADA for which language to use
- DR reiterates to adopt ADA for wordsmithing issues only and not substantive differences
