DECISION

NOT YOUR AVERAGE JOE'S, INC. DBA NOT YOUR AVERAGE JOE'S 291 MAIN ST. SUITE 30 ACTON, MA 01720 LICENSE#: 000600036 HEARING HELD: 1/10/2012

Not Your Average Joe's, Inc. dba Not Your Average Joe's (the "Licensee") holds an all-alcoholic beverages license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, January 10, 2012, regarding an alleged violation of M.G.L. c. 138, §34. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Brad Doyle's Compliance Check Field Report.

FACTS

1. On July 28, 2011, at approximately 1:28 p.m., Commission Investigators Doyle and Bailey conducted an investigation of the licensed premises operating as a restaurant, Not Your Average Joe's, Inc. dba Not Your Average Joe's.

2. An underage operative, working with the Investigators, purchased an alcoholic beverage, a bottle of Budweiser beer, for four dollars and twenty-four cents (\$4.24). The underage operative was not asked for identification.

3. The underage operative was eighteen (18) years of age, with a date of birth of October 14, 1992.

4. The licensee has held the license since 2005, and has no history of violations.



CONCLUSION

Based on the evidence, the Commission finds the licensee violated Massachusetts General Laws c. 138, §34. The Commission suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
