## FINAL DECISION

I adopt the Recommended Final Decision as my final decision in this matter. I affirm the Superseding Determination of Applicability ("SDA") issued on September 1, 2022 by the Southeast Regional Office of the Massachusetts Department of Environmental Protection, with the clarification that Proposed Tailwater Pond 2, also referred to as the 5-Acre Bog or Frogfoot Bog, is no longer Land in Agricultural use and is subject to wetlands permitting review under the Massachusetts Wetlands Protection Act ("MWPA"), G.L. c. 131, § 30, and the Wetlands Regulations at 310 CMR 10.00.

The parties to this proceeding are notified of their right to file a motion for reconsideration of this decision, pursuant to 310 CMR 1.01(14)(d). Any such motion must be filed with the Case Administrator and served on all parties within seven business days of the postmark date of this decision. A person who has the right to seek judicial review may appeal this decision to the Superior Court pursuant to M.G.L. c. 30A, §14(1). Any such appeal must be filed with the Court within thirty days of receipt of this decision.
