Ambnik LLC d/b/a Val's Variety ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, December 5, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Quinn & Cutter's Minimum Purchase Age Compliance Check Field Report.

FINDINGS OF FACT

- 1. On Thursday, June 22, 2023, at approximately 5:28 p.m., Investigators Quinn and Cutter ("Investigators") conducted a compliance check at Ambnik LLC d/b/a Val's Variety.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 357 milliliter bottle of Gilby's Gin, for six dollars and ninety-nine cents (\$6.99). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2019 with no prior violations.

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING**.
