DECISION

TRI PETROLEUM LLC D/B/A MOBIL 160 HOWLAND AVE ADAMS, MA 01220 LICENSE#: 89165-PK-0010

VIOLATION DATE: 6/22/2023

HEARD: 12/05/2023

Tri Petroleum LLC d/b/a Mobil ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, December 5, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Quinn and Cutter's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Quinn and Cutter's Minimum Purchase Age Compliance Check Field Report, 6/22/2023;
- 2. ABCC Application Summary, New License Approved, 10/3/2017;
- 3. Licensee's Stipulation of Facts.

FINDINGS OF FACT

- 1. On Thursday, June 22, 2023, at approximately 5:49 p.m., Investigators Quinn and Cutter ("Investigators") conducted a compliance check at Tri Petroleum LLC d/b/a Mobil.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 16-ounce can of Spiked Arnold Palmer, for three dollars (\$3.00). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2017 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING**.
