Jones & Dews WX Restaurant Group LLC d/b/a Firehouse Café ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, October 18, 2022, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Keefe's Report.

The following documents are in evidence:

- 1. Investigator Keefe's Minimum Purchase Age Compliance Check Field Report;
- 2. ABCC Licensing Authority Certification, New License Approved, 3/23/2022;
- 3. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

FINDINGS OF FACT

- 1. On Wednesday, June 22, 2022, at approximately 6:30 p.m., Investigator Keefe ("Investigator"), inspected the business operation of Jones & Dews WX Restaurant Group LLC d/b/a Firehouse Café.
- 2. An underage operative, working under the supervision of the Investigator, was served an alcoholic beverage, one Steel Rail Ale. The underage operative was not asked for identification.

3. Warren Dews Jr., co-owner and Manager of Record, appeared at the Commission hearing and testified the Licensee's policy is to request identification from all patrons. He stated both the waitstaff and bartenders check identification as a way of being doubly careful.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING.**
