On August 1, 2001, the Cable Television Division ("Cable Division") of the Department of Telecommunications and Energy issued a rate order concerning Adelphia Communications Corporation's ("Adelphia") proposal to establish basic service tier ("BST") programming rates on Federal Communications Commission ("FCC") Form 1240s for the above-referenced communities. <u>Adelphia</u> <u>Communications Corporation</u>, CTV 00-11 (the "Rate Order"). In the Rate Order, the Cable Division approved the BST rates that Adelphia had proposed for the majority of its Massachusetts communities, but directed Adelphia to refile its FCC Form 1240s for the communities of Duxbury, Essex, Falmouth, Great Barrington, Kingston, Lee, Lenox, Plymouth, Sheffield and Stockbridge. The Cable Division directed Adelphia to file amended FCC Form 1240s for these communities, by removing true-up that is claimed but not passed through to subscribers from Line H14, and reporting this true-up on Line H15.

On August 22, 2001, Adelphia filed amended FCC Form 1240s with the Cable Division for Duxbury, Essex, Falmouth, Great Barrington, Kingston, Lee, Lenox, Plymouth, Sheffield and Stockbridge. The Cable Division has reviewed these FCC Form 1240s, and has determined that they comply with the Rate Order and the FCC's rate regulations.

The Cable Division is providing a final schedule of rates with this Order Approving Compliance Filing that reports the proposed and approved rates for all of Adelphia's Massachusetts communities. This final schedule of rates also corrects two typographical errors that appeared on the preliminary rate schedule attached to the Rate Order.

Accordingly, it is

### ORDERED:

Upon due notice, hearing and consideration, the Cable Division hereby accepts as reasonable and in compliance with applicable statutes and regulations, Adelphia's FCC Form 1240s as filed on August 22, 2001 for Duxbury, Essex, Falmouth, Great Barrington, Kingston, Lee, Lenox, Plymouth, Sheffield and Stockbridge.
