**HCPCS Updates and Corrections**

Under the authority of Regulation 101 CMR 334.01(4), the Executive Office of Health and Human Services is adding new codes, deleting outdated codes, and revising descriptions for existing codes for services provided on or after January 1, 2015.

New codes with associated Medicare fees are set at a percentage of prevailing Medicare fees as described in 101 CMR 334.01(4)(d). For existing codes for which only the description has changed, the rates are unchanged, as described in 101 CMR 334.01(4)(b). Codes without associated Medicare fees are set based on the Individual Consideration methodology under 101 CMR 334.02 until appropriate rates are developed.

The following codes are new:

New Code	Rate	Description
L3981	855.80	Upper extremity fracture orthosis, humeral, prefabricated, includes shoulder cap design, with or without joints, forearm section, may include soft interface, straps, includes fitting and adjustments
L6026	6,775.43	Transcarpal/metacarpal or partial hand disarticulation prosthesis, external power, self-suspended, inner socket with removable forearm section, electrodes and cables, two batteries, charger, myoelectric control of terminal
L7259	AAC+70%	Electronic wrist rotator, any type

The following codes have been deleted and crosswalked to new codes, as noted below.
