114.3 CMR 22.00 and, upon rescission of 114.3 CMR 22.00, 101 CMR 322.00: Durable Medical Equipment, Oxygen and Respiratory Therapy Equipment

Effective January 1, 2018

HCPCS Updates

Under the authority of Regulation 114.3 CMR 22.01(5) and 22.03(16), the Executive Office of Health and Human Services is updating Healthcare Common Procedure Coding System (HCPCS) codes for 2018 to add new codes for services provided on or after January 1, 2018, and to add a new modifier.

For entirely new codes with associated Medicare fees as of the Administrative Bulletin adoption date, payment rates are set at a percentage of prevailing Medicare fees as described in 114.3 CMR 22.03(16)(a). For entirely new codes without associated Medicare fees as of the Administrative Bulletin adoption date, individual consideration is applied to establish payment as described in 114.3 CMR 22.03(16)(b). The new modifier, codes and corresponding rates established by the Administrative Bulletin will continue in effect under regulation 101 CMR 322.00, upon rescission of 114.3 CMR 22.00 and adoption of 101 CMR 322.00.

The appearance of a modifier or code in the table below does not constitute authorization for or approval of the procedures or services for which rates are determined pursuant to 114.3 CMR 22.00. Governmental units that purchase care are responsible for the definition, authorization, and approval of care to publicly aided individuals.

The following modifier and codes are entirely new and do not crosswalk to an existing modifier or codes.
