**Administrative Bulletin 22-04**  
**101 CMR 314.00: Rates for Dental Services**  
**Effective January 1, 2022**  
**Updated CDT Dental Codes**

Pursuant to 101 CMR 314.01(5) and (6), the Executive Office of Health and Human Services (EOHHS) is adding 16 codes, deleting five codes, cross-walking two codes, and revising definitions for 16 codes as specified in the Current Dental Terminology (CDT) 2022 set by the American Dental Association for the calendar year 2022.

All codes in this bulletin that require pricing are reimbursed at individual consideration (I.C.). Rates listed in this administrative bulletin are applicable until EOHHS issues revised rates. The deleted codes are no longer available for use for dates of service after December 31, 2021.

The following procedure codes are being added.
