

ADMISSION OR RELEASE	ADMISSION TYPE	DASHBOARD FILTER NAME	DESCRIPTION
ADMISSION	ADMISSION (Total)	ADMISSION	Offenders who are admitted to a facility of the DOC or a Sheriff's Office, pursuant to a court order; as a transfer from another custodial facility; pursuant to the execution of a parole violation 15-day detainer or warrant; or pursuant to the execution of an escape warrant. <u>Please note:</u> Offenders can be released one legal status at a criminal justice agency and be admitted to another legal status at the same criminal justice agency, resulting in multiple admissions for the same Offender.
ADMISSION	ARREST	ARREST	The type of admission could not be determined due to conversion from legacy systems or other reasons.
ADMISSION	SENTENCED	COMMITMENT	Offenders who are admitted to the DOC or a Sheriff's Office pursuant to a sentence, or as otherwise prescribed by law.
ADMISSION	READMIT FROM COURT RELEASE	COURT RELEASE – Readmit from court release	Re-admit an Offender who was released by court order, overturned case, or stay of execution.
ADMISSION	ESCAPE RETURN	ESCAPE RETURN	An escape is the act by which an Offender, lawfully sentenced or admitted to the custody of the DOC or a Sheriff's Office, engages in an unauthorized departure from the confines of a correctional institution, the custody of escorting officers, or fails to return from an authorized release to the community at the designated time. An escape return is an admission following the escape. <u>Please Note:</u> “Escape Return” is not an Admission Type used by all agencies, so returned Offenders may not be noted as such. Additionally, the jurisdiction of where the escape occurred, where the apprehension occurred and where the individual is housed after apprehension may not be the same jurisdiction.
ADMISSION	PAROLE DETAINER	PAROLE VIOLATION (including 15-day Parole Detainers)	An Offender under parole supervision may be returned to the DOC or a Sheriff's Office for a parole violation with a new offense or technical parole violation. Parolees may be returned for a period of up to 15 days awaiting the final determination of the Parole Board regarding final revocation of parole. For reporting purposes, Offenders who have been returned to DOC custody pursuant to a parole detainer are included in this group. <u>Please Note:</u> DOC reports parole violation and parole detainer under “Parole Violation”.
ADMISSION	PAROLE VIOLATION	PAROLE VIOLATION	A parolee may be returned to the DOC or a Sheriff's Office for a parole violation with a new offense or technical parole violation. Admissions as parole violators follow the final determination of the Parole Board to revoke the parole release. For reporting purposes, Offenders who have been returned to DOC custody pursuant to a final parole revocation are included in this group.

			<u>Please Note</u> : DOC reports parole violation and parole detainer under “Parole Violation”.
ADMISSION	PRETRIAL	HELD PRE-TRIAL	Individuals housed in DOC or a Sheriff's Office custody prior to, and during a trial, conviction, and sentencing and not yet convicted of a crime. This admission type also includes individuals held for Criminal Probate Contempt. <u>Please Note</u>: For DOC this description includes the admission types “Pre-trial held with bail” and “Pre-trial held without bail”.
ADMISSION	PRETRIAL HELD WITH BAIL	HELD PENDING DISPOSITION WITH BAIL	Individuals housed in DOC or a Sheriff's Office custody who are detained prior to, and during a trial, conviction, and sentencing and not yet convicted of a crime. In this category, the court ordered a specific bail amount that if paid, the Offender can be released and agrees to appear at a specified time and place. <u>Please Note</u>: For DOC this type is reported under "Held Pre-Trial".
ADMISSION	PRETRIAL HELD WITHOUT BAIL	HELD PENDING DISPOSITION WITHOUT BAIL	Individuals housed in DOC or a Sheriff's Office custody who are detained prior to and during a trial, conviction, and sentencing and not yet convicted of a crime. In this category the court has not set a bail amount or the issue related to the detention of the individual is not subject to release by bail. <u>Please Note</u>: For DOC this type is reported under "Held Pre-Trial".
ADMISSION	PROBATION VIOLATION	PROBATION VIOLATOR	An Offender admitted to DOC or a Sheriff's Office to serve a previously imposed sentence of probation (suspended sentence, probation, or split sentence) following a revocation of the terms of probation. This admission type may also include admissions on a probation violation warrant while the revocation process is pending.
ADMISSION	HELD FOR ANOTHER DEPARTMENT	HELD FOR ANOTHER DEPARTMENT	This category is used for Offenders who were received by the DOC or a Sheriff's Office from another state criminal justice agency. <u>Please Note</u>: For DOC this would include “Received from House of Correction”.
ADMISSION	HELD PENDING ARRAIGNMENT BAIL	HELD PENDING ARRAIGNMENT BAIL	This code is used after releasing an individual from either pre-trial status or completion of sentence, when a warrant or WMS warrant is confirmed. This could also account for arrestees as part of a regional lockup agreement.
ADMISSION	TRANSFER	TRANSFER FROM OTHER JURISDICTION	Returns an Offender to the custody of the DOC or a Sheriff’s Office from a different Massachusetts custodial agency. For the DOC, this includes “Return from a House of Correction”.
ADMISSION	UNKNOWN	OTHER ADMISSION	The type of admission could not be determined due to conversion from legacy systems or other reasons.

RELEASE	RELEASE (Total)	RELEASE	Refers to the release of an Offender from DOC or Sheriff's Office by way of bail; expiration of sentence; parole; a release to other jurisdiction; a court release; or other legal release. Offenders may be released to the community or leave the custody of one criminal justice agency and subsequently be admitted to another criminal justice agency. <u>Please Note:</u> Offenders can be released one legal status at a criminal justice agency and be admitted to another legal status at the same criminal justice agency, resulting in multiple releases for the same Offender.
RELEASE	COURT RELEASE	COURT RELEASE	Offenders released from the DOC or a Sheriff's Office via court release including the following: Habeas to Court - Did not Return, Court Release – Sentence revoked / stayed / vacated. Also, this release type may include court releases due to certain special circumstances.
RELEASE	DECEASED	DECEASED	Release due to death of Offender prior to expiration of sentence or while being held in a pre-trial status.
RELEASE	ESCAPE	ESCAPE	An escape is the act by which an Offender, lawfully sentenced or admitted to the custody of the DOC or a Sheriff's Office, engages in an unauthorized departure from the confines of a correctional institution, the custody of escorting officers, or who fails to return from an authorized release to the community at the designated time. <u>Please Note:</u> "Escape Return" is not an Admission Type used by all agencies, so returned Offenders may not be noted as such. RELEASE	MISSING	OTHER RELEASE	The type of release could not be determined due to conversion from legacy systems or other reasons.
RELEASE	PAROLED TO COMMUNITY	RELEASE TO PAROLE SUPERVISION	Offenders released to the community from the DOC or a Sheriff's Office with parole supervision.
RELEASE	PRETRIAL RELEASE	RELEASE TIME SERVED (Habeas to Court and Released Time Served)	Offenders released on a pre-trial status from the DOC or a Sheriff's Office where the Offender was convicted and sentenced to a term of incarceration equal to the time already served in a pre-trial status. <u>Please Note:</u> DOC reports pre-trial releases as "Court Release", "Remain Incarcerated", "Release to another agency", or "Bail/Release on Personal Recognizance", as applicable.
RELEASE	RELEASED ON BAIL	RELEASED ON BAIL	The release of an Offender from the custody of the DOC or Sheriff's Office after paying the court ordered bail amount and agreeing to appear at a specified time and place. <u>Please Note:</u> DOC reports release types of Bail/Release on Personal Recognizance under this definition.

RELEASE	RELEASED ON PERSONAL RECOGNIZANCE	RELEASED ON PERSONAL RECOGNIZANCE	The release of an Offender from the DOC or Sheriff's Office after a court order and agreeing to appear at a specified time and place. Please Note: DOC reports these releases under "Release on Bail" definition.
RELEASE	RELEASED TO ANOTHER CRIMINAL JUSTICE AGENCY	RELEASED TO ANOTHER CRIMINAL JUSTICE AGENCY	Offenders who were released from their current sentence but are still under the custody of another criminal justice agency including: • Parole to Out of State Sentence; • Parole to Federal Authority; • Parole to Immigration; • Parole to a From and After House of Correction Sentence; • Parole to Warrant; • Parole to a From and After DOC Sentence; • Expiration Release to Out of State Sentence; • Expiration Release to Federal Authority; • Expiration Release to Immigration; • Expiration Release to From and After House of Correction Sentence; • Expiration Release to Warrant; • Expiration Release to From and After/Concurrent at DOC; • Bail/Release on Personal Recognizance to Warrant; and • Expiration of fine to a warrant.
RELEASE	RELEASED TO PROBATION WITH OR WITHOUT SUPERVISION	RELEASED TO PROBATION WITH OR WITHOUT SUPERVISION	Offenders released from the DOC or a Sheriff's Office to probation supervision. The period of probation supervision can be actively supervised (e.g., Risk/Need probation) or less actively supervised (e.g., Administrative Probation). Please Note: DOC reports Offenders released to the community with probation supervision as “Released with Supervision” and Offenders with parole supervision as “Released to Parole Supervision”.
RELEASE	RELEASED WITHOUT SUPERVISION	RELEASED WITHOUT SUPERVISION	The release of an Offender from the DOC or a Sheriff's Office to the community by discharge, expiration of sentence, fine paid, expiration of fine, or good conduct discharge (GCD). These Offenders are released without supervision of the Parole Board or Probation.
RELEASE	REMAIN INCARCERATED	REMAIN INCARCERATED	The release of an Offender from one legal status to another within the same criminal justice agency. For example, the release of an offender from one sentence to a From & After (F/A) sentence. Please Note: DOC court releases to another sentence are reported under this definition.
RELEASE	RELEASE WITH SUPERVISION	RELEASE WITH SUPERVISION	The release of an Offender from the custody of the DOC or a Sheriff's Office to the community by discharge expiration of sentence, fine paid, expiration of fine, or good conduct discharge (GCD). These Offenders are released with Probation supervision. Offenders released with both supervision of the Parole Board and Probation supervision are listed under “Released to Parole Supervision”.

RELEASE	RELEASED TO HOME CONFINEMENT	RELEASED TO HOME CONFINEMENT	A Sheriff's Office may use this release type for pre-trial Offenders or incarcerated individuals released by the court to GPS/ELMO/Home Confinement. <u>Please Note:</u> DOC reports the Release from Home Confinement to the community under other release types.
RELEASE	TRANSFER	TRANSFER TO ANOTHER CRIMINAL JUSTICE AGENCY	Transfer from the custody of the DOC or a Sheriff’s Office to the custody of a different Massachusetts custodial agency. For DOC, this includes Transfer to House of Correction, and Non-DOC Inmate to HOC/FED/PD/Other State.
