- The meeting was called to order at 1:35 P.M. -

1. Approval of the June Minutes

Joe Larson motioned that the June minutes be accepted, Kevin Powers seconded. One clarification to Dave Small's comment in those draft minutes was amended as follows: "The Webinar Hosted by Athol Bird and Nature Club was presented by State Herpetologist Mike Jones on MA Turtles and had 100 participants". The committee members voted unanimously to approve minutes as amended.

2. Vice Chair's Comments – Tim Flanagan

3. Board Member's Comments – Joseph Larson

4. NHESP Report & Assistant Director's Report – Eve Schlüter

Peter Hazelton has left NHESP. Peter will be missed as he accepted a position at the University of Georgia in Athens. We all wish him well. His position is not going to be backfilled in the near term.

Staff have been productive and efficient during the pandemic. Work continues on the online permit filing system and an updated version of VPRS with integration and a new name on track for an end-of-year rollout.

A grant proposal was submitted by a consortium of states for the research on Wood Turtles. Mike Jones was a lead author of the grant representing Massachusetts.

Progress on the Recovering America's Wildlife Act has been made as it has been included in a transportation bill passed by the house. These funds would be used for implementation of the MA State Wildlife Action Plan (SWAP), which includes plants. Links to the bill are below:

5. The Great Marsh Resiliency Project – Russ Hopping, Lead Ecologist, Coastal Ecology, The Trustees

The 16000 acre Great Marsh reaches from Gloucester to Salisbury. A 2017 report from Woods Hole on vulnerability of the Massachusetts coastline to sea level rise emphasized the role of the Great Marsh in mitigating changes. The marsh is critical habitat for the listed Salt Marsh Sparrow and is an important feeding area for breeding terns.

The Trustees have embarked on an innovative restoration project to restore the hydrologic integrity of the marsh. A pilot project started in 2019 took into account the historic infrastructure of the marsh. The ditches and banks (some dating back to the 1600's) were being utilized in the restoration. Russ explained the use of salt hay in filling the ditches from the bottom and slowly mitigating the draining of the marsh. Russ went into detail on the methodology and the hopes of changing the marsh structure to avoid the degradation projected by the SLAMM Model from 2030 – 2070 which would eliminate Salt Marsh Sparrow habitat.

The permitting process is very slow and some improvements will need to be made to get the restoration to a 1,000 acre/year model that would be vital for the recovery of the habitat.
