Southbridge Runway Reconstruction: Runway 2-20 and Taxiway "A" Improvements

- This project involves the reconstruction of Runway 2-20, Taxiway A, runway approach clearing, new runway and taxiway lighting, new navigational aids, and relocation of a public road
- The total cost of the FAA project is approximately \$7.3M with a state share of \$310K
- This project received additional grant assistance through the Federal CARES Act which equates to approximately \$700K
- The runway approach clearing began in March and should be completed by end of April
- The Runway 2-20 and Taxiway "A" reconstruction began at the beginning of April and should be completed in 90 days
- The project will provide a safer surface for aircraft to operate, update the taxiway geometry to current standards, and provide new updated lighting and navigational aids





Nantucket Conservation & Management Permitting: Capital Improvement Plan (CIP) Projects

- Nantucket Memorial Airport has completed a 5-Year CIP to support current and future aviation demand
- Ten of the CIP projects will require review/approval by the MA National Heritage & Endangered Species Program (NHESP) and include runway, taxiway, and airfield improvements
- The Conservation and Management Permit application provides information on existing/proposed conditions, analyzes impacts to state-listed species and proposes a Conservation and Management Plan (CMP) that requires approval by the NHESP Office
- The CMP plan was approved on 3/17/22 and MA Fisheries & Wildlife issued a draft permit to the airport for the 10 projects
- The language in the draft permit is currently being finalized by National Heritage and the final permit is anticipated by late spring

Damage Assessment of MBTA Parking Garage Collapse: Aeronautics uses Drones for Post Incident Inspection

- e: Massachusetts Department of Transportation Aeronautics Division
- Provided video footage of tunnels after partial building collapse at 1 Congress Street parking garage within hours of initial request for assistance by MBTA on Sunday, 27 March
- Flew drone through Orange and Green Line tunnels in Government Center, Haymarket, and North Station to inspect existing conditions for safe access prior to structural engineers entering for further analysis
- Safety assessment by drone video ahead of access by engineering crews potentially allowed the Orange Line to open earlier
- Delivered data on-site, immediately after collection, enabling instantaneous access and analysis by engineers
- Video footage was also used for communications and news broadcasting to inform the public
