TO: Adult Foster Care Providers Participating in MassHealth

FROM: Wendy E. Warring, Commissioner

**RE:** Adult Foster Care Manual (Changes to Service Codes and Descriptions)

This letter transmits revisions to the list of MassHealth-covered service codes and descriptions in Subchapter 6 of the *Adult Foster Care Manual*. These revisions are effective for dates of service on and after **February 1, 2003**.

The Centers for Medicare and Medicaid Services (CMS) have revised the Healthcare Common Procedure Coding System (HCPCS) for 2002. The Division is replacing MassHealth local codes with new national procedure codes to ensure that the Division's coding requirements are compliant with HIPAA (the Health Insurance Portability and Accountability Act of 1996). Please note that you must use a modifier in some cases to accurately reflect the service provided. The modifier must be entered directly after the service code in Item 28 of claim form no. 9 or its electronic equivalent. The attached Subchapter 6 contains codes with modifiers, where applicable.

#### **Billing Guidelines**

What follows is a crosswalk table describing changes from local "X" codes to the new codes.
