7. Old business (The Board may or may not discuss):
 - 55 Fruit Street, Boston, MA – The petitioner’s representatives were in
front of the Board on May 12, 2020 seeking a variance to install PurHealth
Escalator and Moving Walkway Handrail Disinfecting Systems at the
above location. Placed on hold for 90 days for the applicant to revise the
submission. **Deadline: August 10, 2020.**
 - 99 Suffolk Street, Holyoke, MA – The petitioner was in front of the Board
on July 21, 2020 appealing an Inspector’s Report in regard to safety
bulkhead. Placed on hold for 30 days for the applicant to provide the
Board with additional information. **Deadline: August 20, 2020.**
 - 334 Huntington Avenue – Boston, MA
The petitioner was in front of the Board on July 28, 2020 seeking a
product variance for a prototype approval of an Otis Cab Air Purifier.
Placed on hold for 30 days for the applicant to provide the Board with
additional information. **Deadline: August 27, 2020.**
 - Discussion regarding 524 CMR 35:00 Section 2.8.3.3 – Sprinklers shall
not be permitted in power passenger or freight elevator hoistways, pits,
machine rooms or control spaces – consideration of other types of
systems.
 - Discussion regarding the adoption of the 2016 elevator code.
 - Discussion regarding new Controller/Fire Service.
