- B. *Pesticide Product Registrations*: The Pesticide Board Subcommittee will consider for registration the pesticide products in the cover sheet for the January 19, 2021 meeting.
- C. *Section 18 Emergency Exemption Request*: The Pesticide Board Subcommittee will consider the Recertification Request for Pronamide (Kerb SC, 35.6% a.i., EPA 62719-578) in the 2021 Use Season for the Control of Dodder in Cranberries.
- D. *Experimental Use Permit (EUP) application*: The Pesticide Board Subcommittee will consider the approval of an EUP for the use of 1-aminocyclopropane carboxylic acid (ACC) as a plant growth regulator (used as a thinning agent) on apple and stone fruit.
- E. *New Active Ingredient*: The Pesticide Board Subcommittee will consider the registration of *Pyridate* formulated in Tough 5EC Herbicide (EPA Reg. No. 91746-5) labeled for the post-emergence control of annual broadleaf weeds in field corn, chickpea (Garbanzo beans), and mint
