This motion should describe the alleged substantial breach of a material term. The moving party shall provide a copy of the motion to the other side.
- ___ The parties understand and agree that no evidence has been taken in this matter. The signing of this Agreement for judgment does not mean anyone admits to any wrongdoing.
- ___ If the Defendant(s) fail(s) to appear and a default has entered, the Plaintiff(s) agree to allow the Defendant(s) to appear in court and sign the original Agreement in the presence of a Housing Specialist by _____ and the default shall be vacated.
- ___ If the terms of this Agreement are fully complied with, the parties will jointly file a motion to vacate the judgment. This will result in the dismissal of this case. If the parties cannot agree to a joint motion, either party can file a motion to vacate the judgment and the court will schedule a hearing.
- ___ Tenancy shall be reinstated upon dismissal.
