## **FINAL DECISION**

I am the Final Decision-Maker in this administrative appeal (“appeal”) by special designation.

On June 24, 2024 the Massachusetts Department of Environmental Protection (“MassDEP” or “the Department”), issued a \$500.00 Reporting Penalty Assessment Notice (“RPAN”) to A&J Automotive, (“the Petitioner”) that is the subject of this appeal. On August 26, 2024 the Petitioner paid the full amount of the RPAN which was confirmed in the parties Joint Stipulation of Dismissal . Accordingly, this appeal is moot and pursuant to 310 CMR 1.01(8)(c), the appeal is dismissed with the parties waiving whatever rights they may have to further administrative review before MassDEP as well as any appeal to court.
