### **FINAL DECISION AFTER REMAND**

I adopt the Recommended Final Decision After Remand of the Presiding Officer and state only that the resolution of the “redefining the source” and Best Available Control Technology (BACT) issues represent independent bases for affirming the air permit. The parties to these proceedings are notified of their right to file a motion for reconsideration of this decision, pursuant to 310 CMR 1.01(14)(d). The motion must be filed with the Case Administrator and served on all parties within seven business days of the postmark date of this decision. A person who has the right to seek judicial review may appeal this decision to the U.S. Court of Appeals for the First Circuit (“the First Circuit”) pursuant to the Federal Natural Gas Act, 15 U.S.C. § 717r(d)(1) and M.G.L. c. 30A, §14(1).


