Martin Suuberg, the Commissioner of the Massachusetts Department of Environmental Protection (“MassDEP” or “the Department”), has designated me as the Final Decision Maker in this appeal.

The Petitioner Town of Mashpee filed this appeal challenging the Title 5 Plan/Application Approval that the Southeast Regional Office of the Massachusetts Department of Environmental Protection (“MassDEP” or “the Department”) issued to the Applicant, ALJ Realty Corporation on August 9, 2021.

On June 30, 2022, the Applicant withdrew its application with the Department for the Title 5 Large System Upgrade. The Applicant’s withdrawal of its application rendered the Town of Mashpee’s appeal in this matter moot. Accordingly, the Town of Mashpee’s appeal is dismissed as moot.
