DECISION

E & K LIQUORS INC. D/B/A 110 LIQUORS
25 MACY STREET
AMESBURY, MA 01913

E & K Liquors Inc. d/b/a 110 Liquors ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a hearing on Tuesday, September 23, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Bolcome and Anderson's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Bolcome & Anderson's Minimum Purchase Age Compliance Check Field Report;
 2. ABCC Application Summary Review, License Transfer Approved, 8/23/2018;
 3. Licensee Stipulation of Facts.

FINDINGS OF FACT

1. On Monday, June 2, 2025, at approximately 6:43 p.m., Investigators Bolcome and Anderson ("Investigators"), conducted a compliance check at E & K Liquors Inc. d/b/a 110 Liquors.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 6-pack of Coors Banquet beer for nine dollars and twenty-nine cents (\$9.29). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2018 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a WARNING.
