AMMP Goal

- DCR's Asset Management Modernization Program, AMMP, will implement a new web-based asset management solution to inventory major assets and infrastructure, capture and track work orders, prompt regular preventive maintenance, and help to inform deferred maintenance needs.
- The new system, CAMIS, will be able to provide DCR staff real time data, reports and dashboards to efficiently track work order progress and pinpoint areas of resource needs. This new system will replace the current 15+ year old platform.



AMMP Goal

- DCR's AMMP team is developing new work order processes as well as performance standards for corrective, preventative and deferred maintenance projects.
- The current system will be retired and CAMIS will be implemented by the end of 2020.

Summary of Infrastructure

- Currently known DCR inventory:
 - Over 1,900 buildings and improvements
 - Over 2,000 pieces of equipment
 - Over 150 miles of roadways
- Inventory active in CAMIS:
 - Over 900 buildings and improvements
 - Over 1400 pieces of equipment


Challenges and Solutions

 - Land ID webmap
 - Cross-agency collaboration workflow
 - Collector application




Land ID Challenge - Webmap Solution

- DCR found discrepancies with land IDs
- Working in collaboration with DCAMM, we were able to clean up the data by implementing a webmap tool that identifies issues



Example of extreme case of discrepancy found with multiple Land IDs in one parcel




Example of correct configuration of one land ID to one parcel


- August 2018 rink and pool data collected on paper by seasonal staff

Data Collection Innovation

- October 2019 AMMP GIS Analyst developed an interactive map using the Collector App
- The map provides building data which helps data collectors confirm what they are seeing on the ground
- Collectors can then click on the building to edit the attributes
- Creates efficiencies in QA/QC process
