**RE:** ***Acute Outpatient Hospital Manual: Updates to Subchapter 6 (2026 CPT/HCPCS)***

### **Revisions to Subchapter 6**

This letter transmits revisions to the service codes in the *Acute Outpatient Hospital Manual*. The Centers for Medicare & Medicaid Services (CMS) has revised the Healthcare Common Procedure Coding System (HCPCS) codes for 2026. MassHealth has updated Subchapter 6 to conform to the most recent publication of 2026 Current Procedural Terminology (CPT) and HCPCS codes. For dates of service on or after January 1, 2026, you must use the new codes in order to obtain reimbursement.

Subchapter 6 of the *Acute Outpatient Hospital Manual* also lists CPT codes that are non-payable and Level II HCPCS codes that are payable by MassHealth for this provider type.
