Application Program Interface

9-1-1 Adviser can operate stand alone or interfaced with a CAD. The API includes 50 commands CAD can use to remotely configure the software and control the call taking process. 9-1-1 Adviser notifies CAD when a call taker entry is made using one of 33 event codes. The all caller and vital point narratives sent to CAD are configurable using the administrative component editors. Additionally, CAD can request the configurable short report at any time during a call.

Guide Card Content

APCO has developed guide card sets for medical, law enforcement, fire, and missing & exploited children. Any combination of these can be enabled for use in 9-1-1 Adviser. All but the medical guide card content can be changed locally using the editors built into the administrative component. Additional guide cards sets can be created upon request.

System Requirements

The 9-1-1 Adviser software is currently supported on the Windows 7, Vista, and XP operating systems. Installing the software and data files require close to 30 MB of hard drive space. To run the software requires nearly 45 MB of memory. 9-1-1 Adviser runs under version 4.0 of the .NET framework. The bootstrapper on the installation CD will check for and install the .NET framework if it is missing. The .NET framework 4.0 installs on: Windows 7 with or without SP1, Vista with SP1 or SP2, and XP SP3.

9-1-1 Adviser can be configured to archive calls to either an Access or SQL Server database. There are no additional requirements for an Access cases archive. All that is needed is a shared folder on the network. For SQL Server, 9-1-1 Adviser currently supports SQL Server 2000, 2005, 2008, or an equivalent express edition.

To make use of the case report export feature, Microsoft Excel must be installed at each QA position. The export feature directs the results of queries on the cases archive to Microsoft Excel. Within Excel, graphs can be generated using the pivot chart wizard.

Server Operation

The 9-1-1 Adviser software is typically installed on individual workstations and only a single instance is permitted to run at any time. To run from a server requires the software be configured to allow multiple instances and a specially designed interface in order to connect to each instance. 9-1-1 Adviser listens for connection requests on two different ports, one fixed and one random. In order for CAD to establish a connection to each instance, it needs to connect to the fixed port first then request and connect to the random port. Once a connection is established on the random port, the fixed port is freed up for the next instance.
