## **Authority**

This hearing was conducted pursuant to Massachusetts General Laws Chapter 118E, Chapter 30A, and the rules and regulations promulgated thereunder.

## Jurisdiction

Through a notice dated March 29, 2021, MassHealth denied Appellant's prior authorization request for comprehensive orthodontics (<u>Exhibit A</u>). A Request for Fair Hearing was filed on April 20, 2021 (<u>Id</u>). Denial of a prior authorization request constitutes valid grounds for appeal (130 CMR 610.032).

A hearing was held June 30, 2021 at which time MassHealth had a motion pending before the Board of Hearings to have this appeal, along with others, dismissed on the grounds that the provider, who filed for the appeal and appeared at the hearing on Appellant's behalf, was not an "appeal representative" in accordance with 130 CMR 610.004. That motion was granted by the Director of the Board of Hearings on July 8, 2021. Pursuant to that decision, this appeal has been dismissed.
