This hearing was conducted pursuant to Massachusetts General Laws Chapter 118E, Chapter 30A, and the rules and regulations promulgated thereunder.

Jurisdiction

Through a notice dated April 27, 2022, MassHealth denied the appellant's request for prior authorization of comprehensive orthodontic treatment (see 130 CMR 420.431 and Exhibit 4). The appellant filed this appeal in a timely manner on May 27, 2022 (see 130 CMR 610.015(B) and Exhibit 2). Denial of a request for prior approval is a valid basis for appeal (see 130 CMR 610.032).

Action Taken by MassHealth

MassHealth denied the appellant's request for prior authorization of comprehensive orthodontic treatment.

Issue

The appeal issue is whether MassHealth was correct, pursuant to 130 CMR 420.431, in determining that the appellant is ineligible for comprehensive orthodontic treatment.

Summary of Evidence

The appellant is a minor MassHealth member whose mother appeared at hearing via telephone. MassHealth was represented at hearing via telephone by Dr. Harold Kaplan, an orthodontic consultant from DentaQuest, the MassHealth dental contractor.

The appellant's provider submitted a prior authorization request for comprehensive orthodontic treatment, including photographs and x-rays, on April 25, 2022. As required, the provider completed the MassHealth Handicapping Labio-Lingual Deviations ("HLD") Form, which requires a total score of 22 or higher for approval or that the appellant has one of the conditions that warrant automatic approval of comprehensive orthodontic treatment. The provider did not find any of the conditions that warrant automatic approval of comprehensive orthodontic treatment. The provider's HLD Form indicates that he found a total score of 22, broken down as follows:

When DentaQuest evaluated this prior authorization request on behalf of MassHealth, its orthodontists determined that the appellant had an HLD score of 20. The DentaQuest HLD Form reflects the following scores:

¹ The HLD Form instructs the user to record the more serious (i.e., higher score) of either the ectopic eruption **or** the anterior crowding, but not to count both scores.

² The HLD scoring instructions state that to give points for anterior crowding, arch length insufficiency must exceed 3.5 mm.

Because it found an HLD score below the threshold of 22 and no autoqualifier, MassHealth denied the appellant's prior authorization request on April 27, 2022.

At hearing, Dr. Kaplan completed an HLD form based on a careful review of the x-rays and photographs. He determined that the appellant's overall HLD score was 20. Dr. Kaplan's HLD Form reflects the following scores:

Dr. Kaplan explained that the main difference between the appellant's provider's score and that of him and DentaQuest is that the appellant's provider incorrectly scored 5 points for anterior crowding of both the maxilla and mandible. To receive the flat score of 5 points for anterior crowding, there must be at least 3.5mm of crowding. The appellant's upper teeth (or maxilla) do not have at least 3.5mm of crowding, so it should not have been scored. Dr. Kaplan testified that the appellant's crowding in the maxilla, at only 2mm, is minor.

The appellant's mother testified that her child's dentist referred him to an orthodontist due to crowding. Her son sometimes experiences pain when he chews food because his teeth do not align. The appellant is a victim of bullying because of his teeth and she does not want it to lead to depression. He has bad anxiety over his teeth and gets made fun of for it. He regularly comes home from school upset about it. He sees his school guidance counselor weekly.

Dr. Kaplan responded that he understood the appellant's concerns. While appellant's bite would be improved with braces, it is not severe enough for MassHealth to pay for it. He advised the appellant that he may be re-examined every six months and has until the age of 21 to be treated. He also explained the medical necessity narrative which could be included in future prior authorization requests and address the appellant's mental and emotional health. Because the appellant's HLD score is below 22, the appellant does not have a handicapping malocclusion and MassHealth will not pay for comprehensive orthodontic treatment.

Findings of Fact

Based on a preponderance of the evidence, I find the following:

- 1. On April 25, 2022, the appellant's orthodontic provider submitted a prior authorization request for comprehensive orthodontic treatment to MassHealth (Exhibit 4).
- 2. The provider completed a Handicapping Labio-Lingual Deviations Form for the appellant and calculated an overall score of 22 (Exhibit 4).
- 3. The provider did not find any of the conditions that warrant automatic approval of comprehensive orthodontic treatment (Exhibit 4).
- 4. When DentaQuest evaluated the prior authorization request on behalf of MassHealth, its orthodontists determined that the appellant had an HLD score of 20 (Exhibit 4).
- 5. MassHealth approves requests for comprehensive orthodontic treatment when the member has an HLD score of 22 or more (Testimony).
- 6. On April 27, 2022, 2022, MassHealth notified the appellant that the prior authorization request had been denied (Exhibits 1 and 4).
- 7. On May 27, 2022, the appellant filed a timely appeal of the denial (Exhibit 2).

- 8. At hearing, a MassHealth orthodontic consultant reviewed the provider's paperwork, photographs, and x-rays and found an HLD score of 20 (Testimony).
- 9. The appellant's HLD score is below 22.
- 10. The appellant does not have any of the conditions that warrant automatic approval of comprehensive orthodontic treatment (cleft palate, impinging overbite, impaction where eruption is impeded, severe traumatic deviation, overjet greater than 9 mm, reverse overjet greater than 3.5 mm, crowding of 10mm or more, spacing of 10mm or more, anterior crossbite, posterior crossbite, two or more congenitally missing teeth, lateral open bite 2mm or more, anterior open bite 2mm or more).

Analysis and Conclusions of Law

130 CMR 420.431(C)(3) states, in relevant part, as follows:

The MassHealth agency pays for comprehensive orthodontic treatment, subject to prior authorization, once per member per lifetime for a member younger than 21 years old and only when the member has a handicapping malocclusion. The MassHealth agency determines whether a malocclusion is handicapping based on clinical standards for medical necessity as described in Appendix D of the Dental Manual.

Appendix D of the Dental Manual is the "Handicapping Labio-Lingual Deviations Form" (HLD), which is described as a quantitative, objective method for measuring malocclusion. The HLD index provides a single score, based on a series of measurements that represent the degree to which a case deviates from normal alignment and occlusion. MassHealth has determined that a score of 22 or higher signifies a handicapping malocclusion. MassHealth will also approve a prior authorization request, without regard for the HLD numerical score, if there is evidence of cleft palate, impinging overbite, impaction where eruption is impeded, severe traumatic deviation, overjet greater than 9 mm, reverse overjet greater than 3.5 mm, crowding of 10mm or more, spacing of 10mm or more, anterior crossbite, posterior crossbite, two or more congenitally missing teeth, lateral open bite 2mm or more, anterior open bite 2mm or more.

The appellant's provider found an overall HLD score of 22. After reviewing the provider's submission, MassHealth found an HLD score of 20. Upon review of the prior authorization documents, at hearing a different orthodontic consultant found an HLD score of 20.

The main difference between the appellant's provider's score and that of Dr. Kaplan and DentaQuest is that the appellant's provider incorrectly scored 5 points for anterior crowding of both the maxilla and mandible. To receive the flat score of 5 points for anterior crowding, there must be at least 3.5mm of crowding. The appellant's crowding in his upper teeth (or maxilla), at only 2mm, is minor. As his upper teeth do not have at least 3.5mm of crowding, anterior crowding of the

maxilla should not have been scored. Dr. Kaplan's measurements and testimony are credible and his determination of the overall HLD score is consistent with the evidence.

As the appellant does not qualify for comprehensive orthodontic treatment under the HLD guidelines, MassHealth was correct in determining that he does not have a handicapping malocclusion. Accordingly, this appeal is denied.

Order for MassHealth

None.
