## Procedural Background

This hearing was conducted pursuant to Massachusetts General Laws Chapter 118E, Chapter 30A, and the rules and regulations promulgated thereunder. The issue on appeal was MassHealth's October 3, 2022, denial of the Appellant's application for MassHealth due to the Appellant not providing proof in the time allowed. (Exhibit 1; 130 CMR 515.008) The Appellant timely appealed on October 10, 2022. (Exhibit 2; 130 CMR 610.015(B).)

Following the hearing held on November 8, 2022, the record was left open. A subpoena was issued and was to be returned by December 9, 2022, for financial information from an out of state entity. (Exhibit 7) The record was left open until December 16, 2022, for the Appellant to submit necessary financial information and until December 23, 2022, for MassHealth to review the proffered information to determine the Appellant's eligibility. (Exhibit 6) On December 12, 2022, MassHealth correspondence indicated the verifications were received and the Appellant was approved. (Exhibit 8)

As no issue on the appeal of the October 3, 2022 denial notice for missing proof pursuant to 130 CMR 515.008 remains in dispute, this matter is DISMISSED pursuant to 130 CMR 610.051(B).
