## **Procedural Background**

This hearing was conducted pursuant to Massachusetts General Laws Chapter 118E, Chapter 30A, and the rules and regulations promulgated thereunder. The issue on appeal was MassHealth's January 5, 2023 denial of the Appellant's long-term care application because she did not submit the information that MassHealth needed to decide her eligibility within the required timeframe. (130 CMR 515.008; Exhibit 1). The Appellant timely appealed on February 10, 2023. (130 CMR 610.015(B); Exhibit 2).

Following the hearing, the record was left open until April 18, 2023 for the Appellant to submit the outstanding information. The record was also left open until May 2, 2023 for MassHealth to review the submitted documentation. (Exhibit 7). The Appellant subsequently requested to further extend the record open period until May 2, 2023, and until June 16, 2023, which were granted. The record open period was further extended until June 23, 2023 for MassHealth to review the submitted documentation. (Exhibit 8, pp. 3-4, 18). MassHealth subsequently responded that the Appellant's outstanding verifications have been received and approved the Appellant's long-term care application. (Exhibit 8, p. 1).

As no issue on the appeal of the January 5, 2023 denial notice remains in dispute, this matter is dismissed pursuant to 130 CMR 610.051(B).
