Procedural Background

This hearing was conducted pursuant to Massachusetts General Laws Chapter 118E, Chapter 30A, and the rules and regulations promulgated thereunder. The issue on appeal was the January 24, 2023 denial letter of the Appellant's request for long-term care services that were filed on December 8, 2022 because MassHealth determined that the Appellant has more countable assets than MassHealth benefits allow. (See, 130 CMR 520.003; 520.004; Exhibit 1). The Appellant filed this appeal in a timely manner on February 14, 2023. (See, 130 CMR 610.015(B); Exhibit 2).

Following the hearing, the record was left open until April 11, 2023 for the Appellant to submit additional documentation showing asset spend-down. The record was also left open until April 18, 2023 for MassHealth to review the submitted documentation. (See, Exhibit 7). On May 1, 2023, MassHealth indicated that the documentation has been received and the case was approved on April 21, 2023. (See, Exhibit 8, p. 1).

As no issue on the appeal of the January 24, 2023 denial notice for over assets remains in dispute, this matter is dismissed pursuant to 130 CMR 610.051(B).
