This hearing was conducted pursuant to Massachusetts General Laws Chapter 118E, Chapter 30A, and the rules and regulations promulgated thereunder. The appellant submitted a request for prior authorization for personal care attendant (PCA) hours in the amount of 29 hours and 30 minutes of day and evening hours per week and 2 night hours per week. MassHealth approved 26 hours hours and 30 minutes per week of day and evening hours and approved the night hours in full on March 2, 2023. The appellant filed a timely appeal of the modifications on April 4, 2023. A hearing was conducted for this matter on May 8, 2023. All parties appeared telephonically. After hearing, MassHealth agreed to reinstate all hours requested within the appellant's prior authorization request for personal care attendant (PCA) hours, which reflects as follows:

- Meal Preparation: approved at 95 minutes, seven days per week;
- 2. Laundry: approved at 90 minutes per week;
- 3. **Housekeeping**: approved at 90 minutes per week;
- 4. **Shopping**: approved at 90 minutes per week;

As a result of the above-mentioned agreements on all modifications to the appellant's request, there are no longer any issues in dispute, and the appeal is hereby DISMISSED.

### **Order for MassHealth**

None, except to implement the changes as agreed to at the hearing and described above.
